The Assembly Transportation Committee reports favorably and with amendments Assembly Bill No. 445.

This amended bill would prohibit the use of cellular telephones by school bus drivers when they are operating a school bus.

Research indicates that cell phones contribute to driver inattention and may increase the incidence of accidents. The use of these phones by school bus drivers, who already are subject to a higher degree of distraction than most drivers, poses an unnecessary risk.

The bill would permit school bus drivers to use cell phones when the bus is parked in a safe area off the highway or in emergency situations.

A school bus driver who violates the provisions of this bill would be fined not less than \$100 or more than \$250.

The committee amendments remove from the bill permission for school bus drivers to use a cell phone if there are no passengers on the school bus.

This bill was pre-filed for introduction in the 2002 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

The Senate Law and Public Safety and Veterans' Affairs Committee reports favorably Assembly Bill No. 445 (1R).

This bill prohibits the use of cellular telephones by school bus drivers when they are operating a school bus. The bill permits school bus drivers to use cell phones when the bus is parked in a safe area off the highway or in emergency situations.

Under the amended bill, a school bus driver who violates the provisions of this bill would be fined not less than \$250 or more than \$500. As introduced, the bill provided that a violator would be fined \$100 to \$250. The committee amendments also provide that no motor vehicle or automobile insurance eligibility points would be assessed for this offense.

Research indicates that cell phones contribute to driver inattention and may increase the incidence of accidents. The use of these phones by school bus drivers, who already are subject to a higher degree of distraction than most drivers, poses an unnecessary risk.

As amended and released by the committee, this bill is identical to Senate Bill No. 1251, which also was amended and released by the committee on this same date.

The Senate Law and Public Safety and Veterans' Affairs Committee reports favorably and with committee amendments Senate Bill No. 1251.

This bill prohibits the use of cellular telephones by school bus drivers when they are operating a school bus. The bill would permit school bus drivers to use cell phones when the bus is parked in a safe area off the highway and in emergency situations.

Under the amended bill, a school bus driver who violates the provisions of this bill would be fined not less than \$250 or more than \$500. As introduced, a violator would have been fined \$100 to \$250. The committee amendments further provide that no motor vehicle or automobile insurance eligibility points would be assessed for this offense. Other amendments remove a provision providing that the driver may use the cell phone if there are no passengers on the school bus.

Research indicates that cell phones contribute to driver inattention and may increase the incidence of accidents. The use of these phones by school bus drivers, who already are subject to a higher degree of distraction than most drivers, poses an unnecessary risk.

As amended and released by the committee, this bill is identical to Assembly Bill No. 445 (1R), which also was amended and released by the committee on this same date.
