The Assembly Consumer Affairs Committee reports favorably Senate Bill No. 1149.

Senate Bill No.1149 prohibits a retail sales establishment from electronically printing more than the last five digits of a customer's credit card account number, or the expiration date of the customer's credit card, upon any sales receipt provided to the customer at the point of sale.

The bill clarifies that this restriction does not apply to any sales receipt in which the sole means of recording the customer's credit card number is by handwriting or by an imprint or copy of the customer's credit card.

The provisions of the bill do not take effect until January 1, 2004.

This bill is identical to Assembly Bill No.104, which the committee also reported on this date.

The Assembly Consumer Affairs Committee reports favorably Assembly Bill No. 104.

Assembly Bill No. 104 prohibits a retail sales establishment from electronically printing more than the last five digits of a customer's credit card account number, or the expiration date of the customer's credit card, upon any sales receipt provided to the customer at the point of sale.

The bill clarifies that this restriction does not apply to any sales receipt in which the sole means of recording the customer's credit card number is by handwriting or by an imprint or copy of the customer's credit card.

The provisions of the bill do not take effect until January 1, 2004.

This bill is identical to Senate Bill No. 1149, which the committee also reported on this date.

Assembly Bill No. 104 was pre-filed for introduction in the 2002 legislative session pending technical review. As reported, the bill includes changes required by technical review.
