The Assembly Transportation Committee reports favorably Assembly Bill No. 427.

This bill permits a person who leases or owns a motor vehicle and obtains personalized, courtesy, or special license plates for that vehicle to obtain subsequent sets in a series of such plates, differentiated by a subscript, for use upon other motor vehicles owned or leased by that person and provided there is sufficient space on the plates for the series' subscript. The license plates may be used on leased vehicles which are leased from the same lessor or from different lessors.

The fees for subsequent sets would be established by the Chief Administrator of the New Jersey Motor Vehicles Commission.

Currently, a lessee of a vehicle who has been issued a set of personalized, courtesy or special license plates may obtain another set for another leased vehicle only if it is leased from the same lessor as the first leased vehicle.

The bill provides that a person may apply for a subsequent set of plates rather than a second set of license plates. Moreover, the bill provides that leased vehicles may be leased from different lessors and still have license plates from the same series.

This bill was prefiled for introduction in the 2004-2005 session pending technical review which has been performed.

The Senate Transportation Committee reports favorably Assembly Bill No. 427.
