The Assembly Homeland Security and State Preparedness Committee reports favorably Assembly Bill No. 337.

This bill would require the local firemen's relief associations of the New Jersey State Firemen's Association, which pay line of duty and other death benefits, to also pay these benefits to the families of firefighters who have served as federal, State or local law enforcement officers and who died in a terrorist attack.

Relief funds are established and maintained by the local firemen's relief associations pursuant to N.J.S.A.43:17-1 et seq. The current purpose of the relief associations is to establish and maintain a fund for the relief, support or burial of 1) needy firefighters and their families; 2) firefighters and the families of firefighters who are injured or die in the course of doing public fire duty, or who may become needy or disabled or die as a result of doing public fire duty; and 3) firefighters and the families of firefighters who are prevented from working at their full-time jobs because of an injury or illness resulting from doing public fire duty. The relief associations are funded by a two percent surtax on fire insurance policies sold in this State by foreign (out-of-state) insurers. N.J.S.A.54:18-1 et seq.

Upon enactment, the bill would be retroactive to September 11, 2001.

This bill was prefiled for introduction in the 2004 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

The Senate Law and Public Safety and Veterans' Affairs Committee reports favorably Assembly Bill No. 337.
