## STATE OF NEW JERSEY

The Senate Health, Human Services and Senior Citizens Committee reports favorably and with committee amendments Senate Bill No. 2332.

As amended by committee, this bill amends N.J.S.A.26:3D-17 to prohibit smoking in college and university dormitories. Specifically, the provisions of the bill apply to any building used as a student dormitory that is owned and operated or otherwise utilized by a school or institution of higher education. The bill takes effect on the 60th day after enactment.

N.J.S.A.26:3D-17 currently prohibits smoking in classrooms, lecture halls and auditoriums.

The committee amended the bill to add the phrase "or otherwise utilized" to the description of student dormitories that are covered under the provisions of the bill.

As amended, this bill is similar to Assembly Bill No. 3659 (Mckeon/Weinberg.

Specifically, the provisions of the bill apply to any building used as a student dormitory that is owned and operated or otherwise utilized by a school or institution of higher education.

The bill takes effect on the 60th day after enactment.

## **Codey Signs Major Dormitory Safety Legislation**

(TRENTON) – Acting Governor Richard J. Codey today signed legislation to prohibit smoking in public and private college and university dormitories.

"Today we are creating safer, healthier residence halls," Codey said. "Prohibiting smoking greatly reduces the risk of fires and creates a comfortable environment, free of dangerous secondhand smoke."

Codey signed Senate bill S2332 at Drew University in Madison. Codey was joined by bill sponsor Senator Barbara Buono, as well as State Health Commissioner Fred M. Jacobs, M.D., J.D. Other primary bill sponsors include Senator Fred H. Madden (D-Camden, Gloucester), Assemblyman John F. McKeon (D-Essex) and Loretta Weinberg (D-Bergen).

"College students will be able to breathe easier this fall, both from the cleaner air in their rooms and the knowledge that one more safety hazard has been reduced," said Buono (D-Middlesex). "Students at our colleges and universities should realize that while they have the right to choose to smoke and chance the risks that come along with it, those who live in the same dorm shouldn't have to deal with the hazards of cigarette smoke. By requiring smokers to go outside to light up, we are drastically reducing the chance of a fire and reduce others exposure to secondhand smoke."

This is the first law in the nation to prohibit smoking in both private and public institutions. This law will significantly reduce fire risk on campus. Smoking is currently the second leading cause of fire injuries on campus. Additionally, it will also reduce exposure to secondhand smoke, which kills more than 1,000 New Jerseyans annually.

"When it comes to college dormitories, health and safety must be the top priorities of school officials," said Madden (D-Camden, Gloucester). "This bill strikes a balance by recognizing that many college students are adults who can buy cigarettes, but it preserves the safety of dormitories where large numbers of students live, study and sleep. The signing of this measure shows New Jersey's commitment to the safety and well being of its students."

McKeon said, "Since students rank as the number one target for cigarette marketing, college campuses provide the perfect setting for tobacco companies to recruit customers. But with the dramatic increase in student smokers comes an increase in cigarette-related hazards like dormitory fires. Tragic fires at Seton Hall, Chapel Hill, Bloomsburg, and other universities

only underscore the need for stricter, precautionary measures."

Weinberg said, "This measure is as much about health risk as it is about fire safety. The dangers of secondhand smoke are well documented. While I respect an individual's right to smoke, I do not feel this right supercedes the rights of others who wish to remain healthy and smoke-free."

Commissioner Jacobs said, "This legislation will have a material effect on the health of college students by eliminating in their living facilities this known hazard, this proven carcinogen, this documented danger. The science is irrefutable. The danger is preventable and this legislation is an important first step in protecting the citizens of this state from the hazards of secondhand smoke."

On February 14, 2005, a cigarette ignited a dorm fire at Drew University, bringing attention to the dangers of smoking in college residential housing. Previously, state law allowed colleges and universities to designate smoking in specific dorm rooms and allowed students to choose whether they lived with a smoker or non-smoker.
