Title 26. Chapter 2. Part I I (New) Post Polio Sequelae Awareness Program §§1, 2 - C.26:2-180 & 26:2-181

P.L. 2005, CHAPTER 98, *approved June 15, 2005* Assembly, No. 1988

AN ACT concerning post-polio sequelae and supplementing Title 26 1 2 of the Revised Statutes. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. The Legislature finds and declares that: 8 a. There are estimated to be 1.63 million American polio survivors, 9 50,000 in New Jersey alone; b. At least 70% of paralytic and 40% of non-paralytic polio 10 11 survivors are developing post-polio sequelae, which consist of 12 unexpected and often disabling symptoms, including overwhelming fatigue, muscle weakness, muscle and joint pain, sleep disorders, 13 heightened sensitivity to anesthesia, cold and pain, and difficulty 14 15 swallowing and breathing, and which occur 35 years after the initial 16 poliovirus attack; 17 c. Post-polio sequelae can be treated and even prevented if polio 18 survivors are taught to conserve energy and stop abusing poliovirus-19 damaged neurons, muscles and joints and are prescribed needed assistive devices; 20 d. Polio survivors have unique health problems, including sleep 21 disorders, heightened sensitivity to anesthesia, cold and pain, and 22 23 difficulty swallowing and breathing, which require special attention 24 from medical professionals; and 25 e. It is in the public interest to make information about post-polio sequelae available to the general public through health care providers, 26 so that polio survivors and their family members can learn about the 27 28 various aspects of this condition. 29 2. The Commissioner of Health and Senior Services shall establish 30 31 a public awareness campaign to inform the general public about postpolio sequelae, for which purpose the commissioner shall provide for 32 33 the development of educational materials, in consultation with health 34 care facilities and providers that have a demonstrated record of 35 expertise and interest in this subject, which shall be made available to 36 local boards of health, physicians, hospitals and clinics for distribution 37 to consumers. 38 39 3. This act shall take effect immediately.

STATEMENT

3 This bill requires the Commissioner of Health and Senior Services 4 to establish a public awareness campaign to inform the general public 5 about post-polio sequelae. The Assembly Health and Human Services Committee reports favorably Assembly Bill No. 1988.

This bill requires the Commissioner of Health and Senior Services to establish a public awareness campaign to inform the general public about post-polio sequelae. As part of this effort, the commissioner is to provide for the development of educational materials, in consultation with health care facilities and providers that have a demonstrated record of expertise and interest in this subject, which are to be made available to local boards of health, physicians, hospitals and clinics for distribution to consumers.

This bill is based upon one of the recommendations that was presented to the Assembly Health and Human Services Committee in connection with its public hearing on the subject of women and disability-related issues on May 10, 2002.

This bill is identical to Assembly Bill No. 2486 of 2002 (Weinberg/Johnson), which this committee reported during the prior session. The bill passed the General Assembly by 74-0-1 on September 23, 2002 and was pending in the Senate Health, Human Services and Senior Citizens Committee at the conclusion of the 210th Legislature.
