The Assembly Transportation Committee reports favorably and with amendments Assembly Bill No. 3058.

As reported, this amended bill provides that aircraft cannot be rented in New Jersey until the provider of the aircraft has verified the identity of the pilot seeking to rent an aircraft by requesting to examine a government-issued form of photo identification in addition to the person's pilot certificate. The aircraft provider is also required to record or copy the information on the government-issued identification and retain it for five years.

In these times of increased security concerns, it is in the public's interest to require that the identity of a person seeking to rent aircraft be verified before allowing him or her to take control of an aircraft.

A pilot's certificate or license, as currently issued by the Federal Aviation Administration, does not contain a photo of the certificate holder. Federal regulation does require a pilot to carry government-issued photo identification when operating an aircraft.

COMMITTEE AMENDMENTS

The Committee amended the bill by changing the time required for retaining information on the government-issued identification from a period to be determined by the commissioner to a period of five years. The Committee also amended the effective day to change it from the first day of the third day after enactment to 30 days after enactment.

The Senate Transportation Committee reports favorably and with committee amendments Senate Bill No. 1738.

As reported, this amended bill provides that aircraft cannot be rented in New Jersey until the provider of the aircraft has verified the identity of the pilot seeking to rent an aircraft by requesting and examining a government-issued form of photo identification in addition to the person's pilot certificate. The aircraft provider is also required to record or copy the information on the government-issued identification and retain it for five years.

A pilot's certificate or license, as currently issued by the Federal Aviation Administration, does not contain a photo of the certificate holder. Federal regulations do require a pilot to carry government-issued photo identification when operating an aircraft.

The committee amended the bill by changing the time required for retaining information on the government-issued identification from a period to be determined by the Commissioner of Transportation to a period of five years. The committee also amended the effective date to change it from the first day of the third month after enactment to 30 days after enactment.

With these amendments, this bill is identical to A-3058(1R).
