

As amended by the committee, this bill establishes the "New Jersey Lung Cancer Research Fund" and allows taxpayers to donate a portion of their income tax refund to the fund.

The bill provides specifically as follows:

- A taxpayer may make voluntary contributions to the fund by indicating on the taxpayer's New Jersey gross income tax return that a portion of the taxpayer's tax refund or an enclosed contribution is to be deposited in the fund in accordance with the provisions of P.L.1999, c.21 (C.54A:9-25.14).
- The Legislature is to annually appropriate all funds deposited in the fund to the New Jersey State Commission on Cancer Research for lung cancer research projects.
- The commission will receive, evaluate, and approve applications of qualified research institutions for grants to conduct research relating to the causes, prevention, education, screening, treatment, and cure of lung cancer.
- The bill takes effect immediately and applies to taxable years beginning on or after January 1 following enactment.

This bill would permit taxpayers to make voluntary contributions to the New Jersey Lung Cancer Research Fund on their New Jersey gross income tax returns, in addition to any of the following funds to which contributions may currently be made:

-- the Endangered and Nongame Species of Wildlife Conservation Fund;

- -- the Children's Trust Fund;
- -- the Vietnam Veterans' Memorial Fund;
- -- the New Jersey Breast Cancer Research Fund;
- -- the U.S.S. New Jersey Educational Museum Fund;

The Assembly Appropriations Committee reports favorably Assembly Bill No. 3842 (1R).

The bill establishes the "New Jersey Lung Cancer Research Fund" and allows voluntary contributions to the fund by taxpayers on State gross income tax returns.

Monies in the fund will be appropriated annually to the State Commission on Cancer Research. The commission will receive, evaluate and approve applications of qualified research institutions for grants to conduct research relating to the causes, prevention, education, screening, treatment, and cure of lung cancer.

This bill is identical to Senate Bill No. 2502 (1R), as also reported by the committee.

FISCAL IMPACT:

According to the Division on Taxation, Department of Treasury, enactment of this bill will have no impact on the General Fund, except for a minimal administrative cost in the first year to implement the proposal. The division indicated that there was no way to determine how much would be contributed to either the new fund nor any way to estimate what impact designations would have on the existing funds.

BILL DESCRIPTION

Assembly Bill No. 3842 of 2009 establishes a special fund to be known as the "New Jersey Lung Cancer Research Fund" and provides for a designation on the State gross income tax return that will permit taxpayers to make voluntary contributions to the fund to support the efforts and initiatives of the New Jersey Cancer Research Commission for lung cancer.

Lung cancer research project means a scientific research project, approved by the Commission, focusing on the causes, prevention, education, screening, treatment or cure of lung cancer.
