This bill amends N.J.S.A.26:6-8.1 to delete the restriction on which settings a registered professional nurse may make the actual determination and pronouncement of death.

Under current law, a registered professional nurse may make a determination and pronouncement of death if the death occurs in the home or place of residence of the deceased, in a hospice, or in a long-term care facility or nursing home. The provisions of this bill would remove those restrictions and allow a registered professional nurse to make a determination or pronouncement of death, regardless of where the death occurred.

with Assembly Floor Amendments (Proposed By Assemblyman PANTER)

ADOPTED: JUNE 8, 2006

These amendments clarify that the authority of a registered professional nurse to make the actual determination and pronouncement of death is circumscribed by the provisions of the "New Jersey Declaration of Death Act" (N.J.S.A.26:6A-1 et seq.). That law stipulates that a declaration of death upon the basis of neurological criteria (i.e., when a person has sustained irreversible cessation of all functions of the entire brain, including the brain stem) must be made by a licensed physician who is professionally qualified by specialty or expertise.

STATE OF NEW JERSEY

DATED: FEBRUARY 23, 2006

The Assembly Health and Senior Services Committee reports favorably Assembly Bill No. 534.

This bill amends N.J.S.A.26:6-8.1 to delete the restrictions on the settings in which a registered professional nurse may make a determination and pronouncement of death.

Under the current statute, a registered professional nurse may make the actual determination and pronouncement of death if the death occurs in the home or place of residence of the deceased, in a hospice, or in a long-term care facility or nursing home. The provisions of this bill would remove those restrictions and allow a registered professional nurse to make the actual determination and pronouncement of death, regardless of where the death occurred.

This bill is identical to Senate Bill No. 535 (Buono/Madden), which is currently pending before the Senate.

This bill was pre-filed for introduction in the 2006-2007 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.
