

with Senate Floor Amendments (Proposed By Senator CIESLA)

ADOPTED: JUNE 22, 2006

This amendment clarifies that certain conduct that is disruptive to a funeral and its participants is subject to a penalty under the bill. The amendment replaces the phrase "picketing or other protest" with the word "demonstration" and describes those activities that if conducted to impede access to, or if conducted within 500 feet of, a funeral would be considered disruptive. The amendment also adds a definition for the term "demonstration" which is identical to the one used in the recently enacted federal legislation "Respect for America's Fallen Heroes Act".

The amendment is to clarify questions raised regarding the clarity and scope of the bill.

1. a. For purposes of this section, "military funeral" is any funeral, memorial service, funeral procession, burial or interment for an individual who was an active member of any branch of the United States armed forces or a veteran of such service.

A person is guilty of a disorderly persons offense if, with purpose to cause inconvenience, annoyance or alarm, or recklessly creating a risk thereof, the person makes loud and offensive noise, or threatening gestures or engages in any other disturbing or disruptive conduct within 1000 feet of a military funeral.

b. This section applies to conduct during the period beginning 30 minutes prior to the scheduled commencement of a military funeral, and until 30 minutes following the actual completion of the military funeral.

2. This act shall take effect immediately.

STATEMENT

This bill would make it a disorderly persons offense to make loud and offensive noise, or threatening gestures or engage in any other disturbing or disruptive conduct within 1000 feet of a "military funeral." Under the bill, a "military funeral" is any funeral, memorial service, funeral procession, burial or interment for an individual who was an active member of any branch of the United States armed forces or a veteran of such service. This conduct would be prohibited during the period beginning 30 minutes prior to the scheduled commencement of a military funeral, and until 30 minutes following the actual completion of the military funeral.

This bill is in response to recent protests at military funerals around the country, and is an attempt to prevent harassment of bereaved family members during their time of mourning.

- (1) obstructs, hinders, impedes or blocks another person's entry to or exit from the funeral, the funeral procession, the funeral home, church, synagogue, temple or other place of public worship, or
- (2) engages in picketing or other protest activities within 500 feet of the funeral, the funeral procession, the funeral home, church, synagogue, temple or other place of public worship.

SENATE COMMITTEE SUBSTITUTE FOR SENATE, No. 1881

with Senate Floor Amendments (Proposed By Senator CIESLA)

ADOPTED: JUNE 22, 2006

This amendment clarifies that certain conduct that is disruptive to a funeral and its participants is subject to a penalty under the bill. The amendment replaces the phrase "picketing or other protest" with the word "demonstration" and describes those activities that if conducted to impede access to, or if conducted within 500 feet of, a funeral would be considered disruptive. The amendment also adds a definition for the term "demonstration" which is identical to the one used in the recently enacted federal legislation "Respect for America's Fallen Heroes Act".

The amendment is to clarify questions raised regarding the clarity and scope of the bill.
