An active duty member of the Armed Forces of the United States or a reserve component thereof who has been called to active 11 12 duty by order of the President of the United States or the Secretary 13 of the United States Department of Defense, shall receive veteran's 14 preference under chapter 5 of Title 11A of the New Jersey Statutes, 15 for prospective appointment only, if that active duty member submits proof of veteran status within three days for examinations 16 17 held in the year 2006 and within seven days each year thereafter, of the date an open competitive eligible list, for which that member 18 19 received a passing score, is promulgated.]¹ 20 21 ¹1. N.J.S.11A:5-1 is amended to read as follows: 22 11A:5-1. As used in this chapter: <u>a.</u> "Disabled veteran" means 23 any veteran who is eligible to be compensated for a service-24 connected disability from war service by the United States Veterans Administration or who receives or is entitled to receive equivalent 25 compensation for a service-connected disability which arises out of 26 27 military or naval service as set forth in this chapter and who has 28 submitted sufficient evidence of the record of disability incurred in 29 the line of duty to the Adjutant General of the Department of 30 Military and Veterans' Affairs on or before the closing date for filing an application for an examination and received a 31 32 determination of status no later than eight days prior to the issuance 33 of an employment list, for which that individual received a passing 34 score on an examination; 35 b. "Veteran" means any honorably discharged soldier, sailor, 36 marine or nurse who served in any army or navy of the allies of the 37 United States in World War I, between July 14, 1914 and November 38 11, 1918, or who served in any army or navy of the allies of the 39 United States in World War II, between September 1, 1939 and 40 September 2, 1945 and who was inducted into that service through EXPLANATION - Matter enclosed in bold-faced brackets thus in the above bill is not enacted and is intended to be omitted in the law.

Matter underlined <u>thus</u> is new matter.

(6) Lebanon peacekeeping mission, on or after September 26, 13 14 1982, who has served in Lebanon or on board any ship actively 15 engaged in patrolling the territorial waters of that nation for a 16 period, continuous or in the aggregate, of at least 14 days 17 commencing on or before December 1, 1987 or the date of 18 termination of that mission, as proclaimed by the President of the 19 United States or Congress, whichever date of termination is the 20 latest, in such active service; provided, that any person receiving an 21 actual service-incurred injury or disability shall be classed as a veteran whether or not that person has completed the 14 days' 22 23 service as herein provided;

STATE OF NEW JERSEY

DATED: MARCH 12, 2007

The Assembly Military and Veterans' Affairs Committee reports favorably Senate, No. 2430 with amendments.

This bill, as amended by the committee, would allow veterans to obtain and show proof of disabled veteran status or veteran status, as appropriate, no later than eight days prior to the issuance of a civil service employment list, for which that individual received a passing score on an examination.

In addition, this bill specifies that, notwithstanding the provision of any law to the contrary, a disabled veteran or veteran who received, from the Adjutant General of the Department of Military and Veterans' Affairs, a determination of such status on or after the closing date of the 2006 Law Enforcement Examination, March 30, 2006, but by December 16, 2006 will have that status recognized and applied to all certifications for that candidate that are issued or will be issued for that examination. If determination of such status is made on or after December 17, 2006 and by the 60th day after the date of enactment of this bill, the status will be recognized and applied to all certifications for that candidate that are issued for that examination after the 60th day of enactment.

Under current law, a person can receive, from the Adjutant General of the Department of Military and Veterans' Affairs, a determination of status as a veteran or disabled veteran, for the purposes of civil service preference pursuant to chapter 5 of Title 11A of the New Jersey Statutes, if the person served in the active military or naval service of the United States in any of the wars or conflicts specified in law and was discharged or released under other than dishonorable conditions.

As amended and reported by the committee, this bill is identical to the Assembly Committee Substitute for Assembly, Nos. 3147 and 3874.

COMMITTEE AMENDMENTS

The committee amendments:

(1) amend the definition of veteran and disabled veteran in the civil service law to require a determination of veteran or disabled veteran status no later than eight days prior to the issuance of a civil service employment list, for which an individual received a passing score on an examination; and

(2) specify that, notwithstanding the provision of any law to the contrary, a disabled veteran or veteran who was a candidate for the 2006 Law Enforcement Examination and received, from the Adjutant General of the Department of Military and Veterans' Affairs, a determination of such status on or after the closing date of that examination, March 30, 2006, but by the 60th day after the date of enactment of this bill, will have that status recognized and applied as specified above.



The Assembly Military and Veterans' Affairs Committee reports favorably Assembly Committee Substitute for Assembly, Nos. 3147 and 3874.

This substitute would allow veterans to obtain and show proof of disabled veteran status or veteran status, as appropriate, no later than eight days prior to the issuance of a civil service employment list, for which that individual received a passing score on an examination.

In addition, the substitute specifies that, notwithstanding the provision of any law to the contrary, a disabled veteran or veteran who received, from the Adjutant General of the Department of Military and Veterans' Affairs, a determination of such status on or after the closing date of the 2006 Law Enforcement Examination, March 30, 2006, but by December 16, 2006 will have that status recognized and applied to all certifications for that candidate that are issued or will be issued for that examination. If determination of such status is made on or after December 17, 2006 and by the 60th day after the date of enactment of this bill, the status will be recognized and applied to all certifications for that are issued for that examination after the 60th day of enactment.

Under current law, a person can receive, from the Adjutant General of the Department of Military and Veterans' Affairs, a determination of status as a veteran or disabled veteran, for the purposes of civil service preference pursuant to chapter 5 of Title 11A of the New Jersey Statutes, if the person served in the active military or naval service of the United States in any of the wars or conflicts specified in law and was discharged or released under other than dishonorable conditions.

As reported, this substitute is identical to Senate, No. 2430 (1R).
