# **STATE OF NEW JERSEY**

#### DATED: JUNE 18, 2007

The Assembly Budget Committee reports favorably Assembly Bill No. 4293.

The bill revises the authorization to collect a fee for the issuance of a burial, removal or transit permit to provide the Commissioner of Health and Senior Services with greater flexibility in establishing the amount of the fee, and to support the operational costs of the New Jersey Electronic Death Registration Support System (NJ-EDRS).

Specifically, the bill provides that the fee, which would be increased from \$1 to \$15 for the first three years and then would be \$5 thereafter, would be deposited in the New Jersey Electronic Death Registration Support Fund established pursuant to section 17 of P.L.2003, c.221 (C.26:8-24.2) rather than directly provided to the local registrar, and that the State registrar would provide such amount from the fee, as the Commissioner of Health and Senior Services determines appropriate, to the local registrar who issued the permit.

#### FISCAL IMPACT:

The Office of Legislative Services estimates that approximately \$1.1 million in revenue may be realized annually by the fee increases. It is assumed that local registrars will continue to receive the same amount of fees currently received or approximately \$75,000.

After three years, the fee is to be reduced from \$15 to \$5 and revenues would decrease to approximately \$400,000 annually.

Assembly Bill No. 4293 of 2006 increases the fee for the issuance of a burial, removal or transit permit from \$1 to \$15 for a period of three years, after which time the fee would be \$5. Further, local registrars would no longer retain the fee revenues. Rather, the revenues would be deposited into the New Jersey Electronic Death Registration Support Fund, and the Commissioner of Health and Senior Services would provide local registrars with a portion of such funds, as deemed appropriate.

The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 2654.

Senate Bill No. 2654 revises the authorization to collect a fee for the issuance of a burial, removal or transit permit to provide the Commissioner of Health and Senior Services with greater flexibility in establishing the amount of the fee, and to support the operational costs of the New Jersey Electronic Death Registration Support System (NJ-EDRS).

Specifically, the bill provides that the fee, which would be increased from \$1 to \$15 for the first three years and then would be \$5 thereafter, would be deposited in the New Jersey Electronic Death Registration Support Fund established pursuant to section 17 of P.L.2003, c.221 (C.26:8-24.2) rather than directly provided to the local registrar, and that the State registrar would provide such amount from the fee, as the Commissioner of Health and Senior Services determines appropriate, to the local registrar who issued the permit.

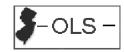
