The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 1950.

This bill creates two additional Superior Court judgeships.

The bill is related to a proposal in the Governor's FY 2009 Budget Recommendation concerning the expansion of the State's drug court program. The addition of the judgeships is a component of this expansion. Drug court is a court-based diversion program that serves as an alternative to incarceration for drug-addicted offenders, who instead receive intensive supervision, drug treatment, counseling and job training.

This bill is identical to Assembly Bill No. 2805.

FISCAL IMPACT:

According to the Administrative Office of the Courts (AOC), the two new judgeships authorized under this bill each require a complete judge team consisting of a Superior Court Judge, a Judge's Secretary, a Law Clerk, a Court Clerk, and an Official Court Reporter. Associated costs include salaries and fringe benefits, office and courtroom space, and start-up, recurring and optional costs. Based on these factors, total expenditures for the additional judgeships is estimated to be \$0.8 million in FY 2009, \$1.1 million in FY 2010, and \$1.1 million in FY 2011.

As noted above, these costs, which are related to the expansion of the State's drug court program are anticipated in the Governor's proposed budget for FY 2009-2010, and are expected to be offset by the net savings to the Department of Corrections county jail budget. Offenders diverted to drug court will no longer need to be held in county jails at State cost while awaiting space in a State prison.

FISCAL ANALYSIS

EXECUTIVE BRANCH

Administrative Office of the Courts

According to the AOC, each judge team consists of a Superior Court Judge, a Judge's Secretary, a Law Clerk, a Court Clerk, and an Official Court Reporter. The AOC notes that under P.L.2007, c.350, Tax court Judges will receive a salary increase effective January 1, 2009. The AOC states that it is unlikely that the program would not become operational until midway through the fiscal near. Given this, salaries are pro-rated to 54 percent of the total annual salary to reflect this assumption. Total salary and fringe benefits costs would equal \$465,986 in FY 2009, \$948,774 in FY 2010 and \$971,780 in FY 2011.

The AOC notes that one-time start-up costs of \$107,760 per judge team, or a total of \$215,520, would be generated to fund office furniture, video court room capability, computers, law books, etc. Continuing operating expenses (office supplies, telephone bills, postage, office machine rentals, etc.) are estimated at \$28,940 during the first year of operation. Second and third-year program costs would total \$30,388 and \$31,906. In addition, the AOC noted that although not included in the cost projection as it is beyond the projection period, after 2 years, the maintenance of the video court capability is approximately \$3,675 per year.

Finally, the AOC stated that for the purpose of this fiscal note, it is assumed that the Judiciary would have to rent 100 percent of the office and courtroom space necessary to facilitate the judge team. Assuming that a 2,000 square foot space per judge team is necessary, at a cost of \$25 per square foot, the annual facility rental cost would total \$100,000 in the first year, \$105,000 in the second year, and \$110,250 in the third year after implementation.

Total annual costs to the Judiciary for the two new judgeships in FY 2009, FY 2010, and FY 2011 are \$810,446, \$1,084,162 and \$1,113,936, respectively.

As noted above these costs, which are related to the expansion of the State's drug court program, are anticipated in the Governor's proposed budget for FY 2009-2010, and are expected to be offset by the net savings to the Department of Corrections county jail budget. Offenders diverted to drug court will no longer need to be held in county jails at State cost while awaiting space in a State prison.

Offenders diverted to drug court will no longer need to be held in county jails at State cost while awaiting space in a State prison.
