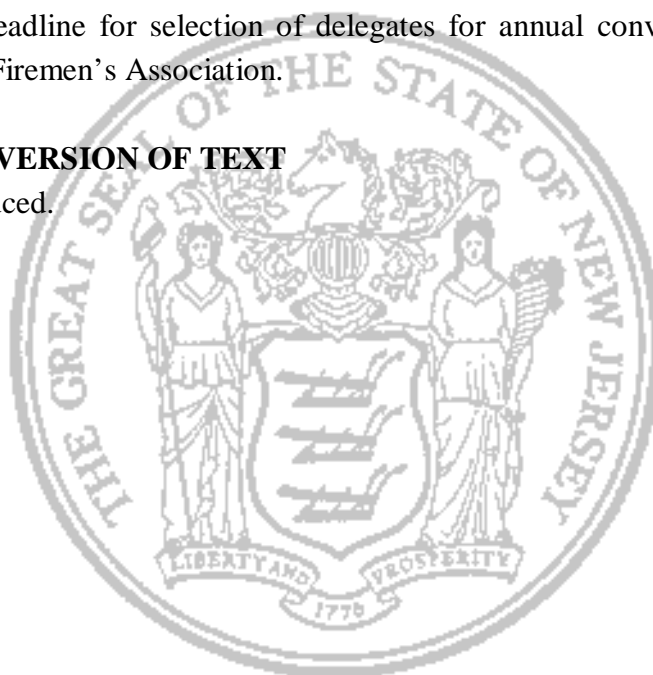

The Assembly Law and Public Safety Committee reports favorably Senate Bill No. 983.

Senate Bill No. 983 changes the deadline for firemen's relief associations and exempt firemen's associations to choose delegates to the annual convention of the New Jersey State Firemen's Association from June 1<sup>st</sup> to May 1<sup>st</sup>.

Under current law, the board of representatives of all local firemen's relief associations are required to select, by June 1st of each year, three delegates and three alternates to the meetings and conventions of the New Jersey State Firemen's Association. In addition, all exempt firemen's associations are required to select by ballot, by June 1st of each year, one delegate and one alternate to represent and vote for the local exempt firemen's association at the State association's meetings and conventions.

Under the provisions of this bill, the delegates are to be selected by May 1st of each year in order to give the State association more time to prepare convention information, such as identification cards, distributed at local and county caucuses.

As reported by the committee, this bill is identical to Assembly Bill No. 2441, also reported by the committee on this same date.
