AN ACT to amend the title of "An act concerning the sale of land by municipalities to volunteer fire companies or first-aid and emergency or volunteer ambulance or rescue squad associations, and supplementing chapter 60 of Title 40 of the Revised Statutes," approved July 15, 1954 (P. L. 1954, c. 143), as said title was amended by chapter 75 of the laws of 1964, so that the same shall read "An act concerning the sale of land by municipalities to volunteer fire companies or first-aid and emergency or volunteer ambulance or rescue squad associations, or mental health commissions, and supplementing chapter 60 of Title 40 of the Revised Statutes," and to amend the body of said act.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. The title of chapter 143 of the laws of 1954, as said title was
2 amended by chapter 75 of the laws of 1964, is amended to read as
3 follows:

4 An act concerning the sale of land by municipalities to volunteer
5 fire companies or first-aid and emergency or volunteer ambulance
6 or rescue squad associations, *or mental health commissions*, and
7 supplementing chapter 60 of Title 40 of the Revised Statutes.

1 2. Section 1 of P. L. 1954, chapter 143 (c. 40:60-40.5) is amended
2 to read as follows:

3 1. When the governing body of a municipality shall determine
4 that any land owned by the municipality is no longer desirable,
5 necessary or required for public purposes, it may by resolution
6 authorize the sale and conveyance of the same for a nominal con-
7 sideration to a duly incorporated volunteer fire company or first-aid
8 and emergency or volunteer ambulance or rescue squad association
9 of the municipality, *or a local mental health commission or asso-*

10 *ciation*, for the erection thereon of a fire house or for the erection
11 thereon of, or the use thereof including any buildings thereon as
12 a fire school or for the erection thereon of a first-aid and emergency
13 or volunteer ambulance or rescue squad association building *or the*
14 *erection thereon of a mental health center.*

15 Any such land including any buildings thereon sold and conveyed
16 to any duly incorporated volunteer fire company may be leased by
17 such fire company to any volunteer fireman's association for the
18 erection thereon of, or the use thereof as, a fire school for the bene-
19 fit of the members of such association.

1 3. This act shall take effect immediately.
