STATE OF NEW JERSEY

PRE-FILED FOR INTRODUCTION IN THE 1968 SESSION

By Senator DUMONT

AN ACT concerning the use of toll roads and other toll facilities by members of the New Jersey National Guard, and supplementing chapter 4 of Title 38A of the New Jersey Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State of New*
2 *Jersey:*

1 1. Any member of the New Jersey National Guard while going to, or
2 returning from, any parade, encampment, drill, or meeting which he may be
3 required to attend under the laws and regulations for said National Guard,
4 shall, together with his conveyance and the military property of the State or
5 of the United States, or both, in his charge, be allowed to pass free of
