AN ACT authorizing cemetery associations to lease certain lands not devoted to cemetery purposes and amending section 8:2-47 of the Revised Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*  
2 *of New Jersey:*

1 1. Section 8:2-47 of the Revised Statutes is amended to read as  
2 follows:

3 8:2-47. A cemetery association incorporated under sections  
4 8:1-1 to 8:1-5 of this Title or under any special act may sell  
5 and dispose of, *or lease for a term of 2 or more years*, such part  
6 of its lands as have not been laid out into burial plots or lots,  
6A *\*when said lands shall have become separated by reason of the inter-*  
6B *section of this association's lands by a State highway,\** and use the  
6C proceeds of such sales *or leases* to pay its debts and liabilities and  
6D to improve its cemetery.

7 *Any lease entered into pursuant to this section shall be acknowl-*  
8 *edged or proved and recorded in the office of the county recording*  
9 *officer and the lands and property the subject of any such lease*  
10 *shall not be entitled to the tax and other exemptions set forth in*  
11 *Revised Statutes 8:2-27.*

1 2. This act shall take effect immediately.

6A and use the proceeds of such sales *or leases* to pay its debts and  
6B liabilities and to improve its cemetery.

7 *Any lease entered into pursuant to this section shall be acknowl-*  
8 *edged or proved and recorded in the office of the county recording*  
9 *officer and the lands and property the subject of any such lease*  
10 *shall not be entitled to the tax and other exemptions set forth in*  
11 *Revised Statutes 8:2-27.*

1 2. This act shall take effect immediately.
