## INTRODUCED APRIL 22, 1968

## By Senator FORSYTHE

(Without Reference)

An Acr concerning highways and bridges over the Delaware river, the responsibilities of the Delaware River Joint Toll Bridge Commission and the New Jersey Department of Transportation with regard to the construction of additional river crossings and supplementing Titles 27 and 32 of the Revised Statutes.

- 1 Whereas, There is a demonstrated need for additional crossings
- 2 of the Delaware river within the jurisdiction of the Delaware
- 3 River Joint Toll Bridge Commission; and
- 4 WHEREAS, The United States Bureau of Public Roads has previ-
- 5 ously indicated a willingness to have constructed as part of the
- 6 Interstate System a new river crossing as part of Interstate
- 7 Route 78 near Easton-Phillipsburg; and
- 8 Whereas, The Delaware River Joint Toll Bridge Commission has
- 9 also publicly indicated the need for new crossings at Burlington-
- 10 Bristol, New Hope-Lambertville and Trenton-Morrisville; and
- 11 Whereas, The construction of the Burlington-Bristol crossing with
- 12 Federal and State funds would substantially reduce the future
- 13 financial requirements of the Delaware River Joint Toll Bridge
- 14 Commission; and
- 15 Whereas, The New Jersey Department of Transportation has in-
- dicated that, under certain conditions, the Federal Government
- is prepared to add the Burlington-Bristol Bridge and the con-
- 18 nector roads from Interstate Route 295 in New Jersey to Inter-
- state Route 95 in Pennsylvania to the present Interstate System;
- 20 and
- 21 Whereas, The Federal Government is desirous of operating the
- 22 Interstate System free from toll facilities to the greatest extent
- 23 possible; and

- 24 Whereas, The Federal Government is seeking the construction of
- 25 the Interstate Route 78 crossing as a nontoll facility within 10
- 26 miles of the existing Easton-Phillipsburg toll bridge and an
- 27 agreement to release from toll operation at a future specific date
- 28 the toll bridge at Delaware Water Gap which is a part of Inter-
- state Route 80; and
- 30 Whereas, It is in the public interest to resolve the present diffi-
- 31 culties preventing prompt construction of all of these bridges
- and wherever possible to operate these bridges as nontoll facili-
- 33 ties; now therefore,
- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The Legislature hereby finds and determines the construction
- 2 of a new river crossing at Burlington-Bristol and an additional
- 3 river crossing at Easton-Phillipsburg as part of the National Sys-
- 4 tem of Interstate and Defense Highways is in the public interest
- 5 and further finds and determines that it is in the public interest
- 6 to have released from toll operation the Delaware river crossing
- 7 that is part of Interstate Route 80 at a date consistent with the
- 8 intention of the Delaware River Joint Toll Bridge Commission to
- 9 construct additional toll crossings in the immediate future in the
- 10 vicinity of New Hope-Lambertville and Trenton-Morrisville, and
- 11 further determines that the Department of Transportation and the
- 12 New Jersey members of the Delaware River Joint Toll Bridge
- 13 Commission should co-operate in an effort to accomplish the con-
- 14 struction of bridges, insofar as possible, in the manner herein set
- 15 forth.
  - 2. Pursuant to the authority set forth in chapter 153, P. L. 1956,
  - 2 the Commissioner of Transportation is further authorized in co-
  - 3 operation with the Department of Highways in the Commonwealth
  - 4 of Pennsylvania and the United States Department of Transporta-
  - 5 tion to construct as part of the National System of Interstate and
  - 6 Defense Highways, a bridge across the Delaware river in the vi-
  - 7 cinity of Burlington, New Jersey and Bristol, Pennsylvania and
  - 8 a bridge across the Delaware river in the vicinity of Phillipsburg,
  - 9 New Jersey and Easton, Pennsylvania.
  - 3. In carrying out the provisions of this act, the Department of
  - 2 Transportation may enter into an agreement with the Delaware
  - 3 River Joint Toll Bridge Commission for the purposes of construct-
  - 4 ing bridges and approaches over the Delaware river in the vicinity
  - 5 of Burlington-Bristol and Easton-Phillipsburg. The cost of such

- 6 construction shall be the responsibility of the States and the Fed-
- 7 eral Government and not the Delaware River Joint Toll Bridge
- 8 Commission. The nonfederal share of the cost shall be divided
- 9 equally between the States. Upon completion, the bridges shall be
- 10 owned by the State of New Jersey and the Commonwealth of Penn-
- 11 sylvania equally and such bridges shall be maintained and operated
- 12 by the Delaware River Joint Toll Bridge Commission as toll-free
- 13 facilities in accordance with the laws applicable to other State-
- 14 owned bridges within the jurisdiction of the Delaware River Joint
- 15 Toll Bridge Commission.
- 4. The Department of Transportation and the Delaware River
- 2 Joint Toll Bridge Commission are hereby authorized to enter into
- 3 such agreements with the Department of Highways of the Common-
- 4 wealth of Pennsylvania and with the Department of Transporta-
- 5 tion of the United States as may be necessary or desirable in order
- 6 to comply with all applicable Federal laws, requirements and regu-
- 7 lations thereunder governing the construction and financing of fa-
- 8 cilities to be incorporated in the National System of Interstate and
- 9 Defense Highways.
- 1 5. Notwithstanding the provisions of this act, the construction
- 2 and operation of the toll-free bridges authorized herein shall be
- 3 carried out in a manner which will not violate any existing covenant
- 4 of the Delaware River Joint Toll Bridge Commission made for the
- 5 protection of holders of its outstanding Bridge Revenue Bonds
- 6 and such bridges shall not be epened to traffic until all such out-
- 7 standing Bridge Revenue Bonds shall have been retired by pay-
- 8 ment, purchase or redemption, or provision for such retirement
- 9 shall have been duly made, or unless the holders of such Bridge
- 10 Revenue Bonds for which provision for retirement shall not have
- 11 been made shall have consented in writing to such bridge opening.
- 1 6. This act shall take effect immediately.
