1 **AN ACT** concerning emergency health powers and supplementing
2 Title 26 of the Revised Statutes.

4 **BE IT ENACTED** *by the Senate and General Assembly of the State*
5 *of New Jersey:*

7 1. All executive orders issued by the Governor prior to the
8 effective date of this act, P.L. , c. (C.) (pending before the
9 Legislature at this bill), that relied on the existence of the public
10 health emergency declared by the Governor in Executive Order No.
11 103 of 2020, as extended, shall expire 30 days following the
12 effective date of this act, with the exception of the executive orders
13 listed in this section that shall remain in effect until January 1,
14 2022. The Governor shall have the ability to revoke or modify the
15 executive orders listed in this section prior to January 1, 2022.

3 COVID-19 response bestowed by either Executive Order No. 112 of
4 2020, P.L.2020, c.18, or Department of Health Executive Directive
5 No. 20-006 (Revised) as issued December 16, 2020 upon health
6 care professionals, health care facilities, health care systems,
7 modular field treatment facilities, and any other sites designated by
8 the Commissioner of the Department of Health for temporary use in
9 connection with the State's COVID-19 response, including hotels
10 and student dormitories, shall last until September 1, 2021, and then
11 expire on that date. Conduct occurring prior to September 1, 2021
12 by health care professionals, health care facilities, or health care
13 systems shall retain the civil or criminal immunity provided by
14 Executive Order No. 112 of 2020, P.L.2020, c.18, or Department of
15 Health Executive Directive No. 20-006 (Revised) as issued
16 December 16, 2020. The civil immunity bestowed upon health care
17 professionals in connection with the State's COVID-19 response by
18 P.L.2020, c.18 shall continue beyond September 1, 2021 only for
19 individuals specifically engaged in vaccinations or testing related to
20 COVID-19.

22 3. a. Following the termination of the public health emergency
23 declared by the Governor in Executive Order No. 103 of 2020, as
24 extended, the force and effect of any administrative order, directive,
25 or waiver issued by the head of a State agency that relied on the
26 existence of the public health emergency declared by the Governor
27 in Executive Order No. 103 of 2020, as extended, shall expire on
28 January 11, 2022. Such administrative order, directive, or waiver
29 may be continued and may be modified by the head of a State
30 agency, unless such administrative order, directive, or waiver is
31 explicitly revoked, until January 11, 2022.

32 b. Notwithstanding subsection a. of this section, the Governor
33 shall notify the Legislature by January 1, 2022 if the Governor
34 determines that it is necessary or appropriate to continue for an
35 additional 90 days beyond January 11, 2022 any administrative
36 order, directive, or waiver issued by the head of a State agency that
37 relied on the existence of the public health emergency declared by
38 the Governor in Executive Order No. 103 of 2020, as extended.
39 The administrative orders, directives, or waivers shall be extended
40 for an additional 90 days if each House of the Legislature passes a
41 concurrent resolution to continue any such administrative order,
42 directive, or waiver. Any administrative order, directive, or waiver
43 as to which the Governor does not provide notification to the
44 Legislature or as to which both Houses of the Legislature do not
45 pass a concurrent resolution to continue shall expire on January 11,
46 2022.

47 c. Notwithstanding subsection a. of this section, the provisions
48 of any administrative order, directive, or waiver issued by the

1 Department of Health that relied on the existence of the public
2 health emergency declared by the Governor in Executive Order No.
3 103 of 2020, as extended, governing staffing ratios, overtime, shifts,
4 and vacation time shall remain in force and effect until September
5 1, 2021, at which time all such provisions of administrative orders,
6 directives, and waivers governing staffing ratios, overtime, shifts,
7 and vacation time shall be superceded by relevant provisions of
8 laws, regulations, or collective bargaining agreements in effect on
9 that date.

10

11 4. The termination of the public health emergency declared by
12 the Governor in Executive Order No. 103 of 2020, as extended,
13 shall in no way diminish, limit, or impair the powers of the
14 Governor or the head of a State agency pursuant to the provisions of
15 the civilian defense and disaster control act P.L.1942, c.251
16 (C.App.A:9-33 et seq.). The state of emergency declared in
17 Executive Order No. 103 of 2020, as extended, pursuant to
18 P.L.1942, c.251 (C.App.A:9-33 et seq.) shall remain in effect until
19 terminated by the Governor.

20 While the state of emergency declared in Executive Order No.
21 103 of 2020 shall remain in effect, the deadlines in paragraph (1) of
22 subsection i. of section 6 of P.L.2001, c.404 (C.47:1A-5) shall
23 apply to any request made under the open public records act after
24 the effective date of this act, with the exception of requests made
25 for records related to the COVID-19 response, which shall continue
26 to be governed by paragraph (2) of subsection i. of section 6 of
27 P.L.2001, c.404 (C.47:1A-5).

29 5. Following the termination of the public health emergency
30 declared by the Governor in Executive Order No. 103 of 2020, as
31 extended, the Governor, Commissioner of Health, and the head of
32 any other State agency may issue orders, directives, and waivers
33 pursuant to P.L.2005, c.222 (C.26:13-1 et seq.) related to (1)
34 vaccination distribution, administration, and management, (2)
35 COVID-19 testing, (3) health resource and personnel allocation, (4)
36 data collection, retention, sharing, and access, (5) coordination of
37 local health departments, and (6) implementation of any applicable
38 recommendations of the Centers for Disease Control and Prevention
39 to prevent or limit the transmission of COVID-19, including in
40 specific settings.

41 The authority granted by this section shall last until January 11,
42 2022, unless the Governor notifies the Legislature by January 1,
43 2022 that the authority granted by this section is necessary to
44 combat the continuing threat posed by COVID-19 and should last
45 for another 90 days. In the event of such notification, the
46 Legislature shall have the authority to pass a concurrent resolution
47 to concur with the Governor's notice. If such a concurrent
48 resolution passes both Houses of the Legislature, then the authority

1 granted by this section shall continue for an additional 90 days. If
2 such a concurrent resolution does not pass both Houses of the
3 Legislature, then the authority granted by this section shall expire
4 on January 11, 2022.

35 which both Houses of the Legislature do not pass a concurrent
36 resolution to continue would expire on January 11, 2022.

37 Under the bill, the provision of any administrative order,
38 directive, or waiver issued by the Department of Health that relied
39 on the existence of the public health emergency declared by the
40 Governor in Executive Order No. 103 of 2020, as extended,
41 governing staffing ratios, overtime, shifts, and vacation time shall
42 remain in force and effect until September 1, 2021, at which time
43 all such provisions of administrative orders, directives, and waivers
44 governing staffing ratios, overtime, shifts, and vacation time will be
45 superseded by relevant provisions of laws, regulations, or collective
46 bargaining agreements in effect on that date.

47 The bill specifies that the termination of the public health
48 emergency declared by the Governor in Executive Order No. 103 of

1 2020, as extended, will in no way diminish, limit, or impair the
2 powers of the Governor or the head of a State agency pursuant to
3 the provisions of the civilian defense and disaster control act
4 P.L.1942, c.251 (C.App.A:9-33 et seq.). The state of emergency
5 declared in Executive Order No. 103 of 2020 pursuant to that law
6 will remain in effect until terminated by the Governor.

7 However, while the state of emergency declared in Executive
8 Order No. 103 of 2020 remains in effect, the deadlines in paragraph
9 (1) of subsection i. of section 6 of P.L.2001, c.404 (C.47:1A-5) will
10 apply to any requests made under the open public records act after
11 the effective date of this bill, with the exception of requests made
12 for records related to the COVID-19 response, which will still be
13 governed by paragraph (2) of subsection i. of section 6 of P.L.2001,
14 c.404 (C.47:1A-5).

15 Following the termination of the public health emergency
16 declared by the Governor in Executive Order No. 103 of 2020, as
17 extended, the Governor, Commissioner of Health, and the head of
18 any other State agency may issue orders, directives, and waivers
19 pursuant to the emergency health powers law, P.L.2005, c.222
20 (C.26:13-1 et seq.), related to (1) vaccination distribution,
21 administration, and management, (2) COVID-19 testing, (3) health
22 resource and personnel allocation, (4) data collection, retention,
23 sharing, and access, (5) coordination of local health departments,
24 and (6) implementation of any applicable recommendations of the
25 Centers for Disease Control and Prevention to prevent or limit the
26 transmission of COVID-19, including in specific settings. The
27 authority granted above will last until January 11, 2022, unless the
28 Governor notifies the Legislature by January 1, 2022 that the
29 authority granted is necessary to combat the continuing threat posed
30 by COVID-19 and should last for another 90 days. In the event of
31 such notification, the Legislature will have the authority to pass a
32 concurrent resolution to concur with the Governor. If such a
33 concurrent resolution passes both Houses of the Legislature, then
34 the authority granted will continue for an additional 90 days. If
35 such a concurrent resolution does not pass both Houses of the
36 Legislature, then the authority granted would expire on January 11,
37 2022.

Immediately following the signing of the legislation, Governor Murphy signed Executive Order No. 244, ending the COVID-19 Public Health Emergency. Under the legislation, the majority of executive orders issued pursuant to the Public Health Emergency will expire 30 days from today.

The legislation, which was negotiated with legislative leadership and sponsored by Senate President Steve Sweeney and Assembly Speaker Craig Coughlin, allows for the termination of the Public Health Emergency while also allowing the Administration to retain the tools necessary to manage the ongoing threat posed by the pandemic. Specifically, the Administration is authorized to issue orders, directives, and waivers under the authority in the Emergency Health Powers Act that are related to vaccination efforts; testing; health resource and personnel allocation; data collection, retention, sharing, and access; coordination of local health departments; and implementation of any CDC recommendations to prevent the transmission of COVID-19. This authority lasts until January 11, 2022, and can be extended for 90 days with the passage of a concurrent resolution by the Legislature.

“Today’s lifting of the COVID-19 Public Health Emergency is a clear and decisive step on the path toward normalcy,” **said Governor Murphy**. “The past 15 months have been a challenge, and I thank every New Jerseyan who stayed home, masked up, took precautions to keep this virus in check, and got vaccinated for allowing us to get to this point. I also thank the Senate President and the Speaker for working with us to responsibly end the Public Health Emergency and meet the challenges ahead.”

The legislation keeps the following 14 executive orders in place until January 1, 2022, though they can be modified or rescinded prior to that date by the Governor:

Further, any administrative orders, directives, or waivers that relied on the existence of the public health emergency, including Department of Health orders that govern vaccinations and testing, are extended until January 11, 2022. The Governor is authorized to seek a further 90-day extension of such orders, directives, or waivers, which can be granted by a concurrent resolution passed by the Legislature.

The legislation also states that while the State of Emergency declared in Executive Order No. 103 shall remain in effect, the previous seven-day requirement for Open Public Records Act (OPRA) responses will be restored for records unrelated to the COVID-19 response. Additionally, civil and criminal immunity given to health care professionals and facilities, including long-term care facilities, and existing waivers of regulations involving staffing ratios, overtime, shifts, and vacation time will expire on September 1, 2021. Civil immunity for health care professionals shall continue beyond September 1, 2021 only for individuals specifically engaged in vaccinations or testing related to COVID-19.

“New Jerseyans have proven their resilience over the past 15 months as our state has fought the COVID-19 pandemic. Today, we take a substantial step toward restoring normalcy to our state and to the lives of those who call New Jersey home.

“Ending New Jersey’s COVID-19 Public Health Emergency is one of the most significant steps we have taken in our recovery efforts to date. With our state’s public health metrics continuing to trend decisively in the right direction, we are confident that now is the right time to take this action, particularly as the final limits on gatherings are lifted tomorrow. With passage of this bill today and its signing tomorrow, followed by the Governor’s signing of an executive order terminating the Public Health Emergency, we will move closer to normal than at any time since March 2020.

Governor Murphy Highlights Aspects of Legislation Allowing for the Termination of the Public Health Emergency Effective as of July 4

07/2/2021

TRENTON – Governor Phil Murphy today highlighted several aspects of legislation allowing for the termination of the Public Health Emergency effective as of July 4. On June 4, 2021, Governor Murphy signed A5820 enabling the end of the COVID-19 Public Health Emergency that had been in place since March 9, 2020. Immediately following the signing of the legislation, Governor Murphy signed Executive Order No. 244 (2021), ending the COVID-19 Public Health Emergency. Under the legislation, the majority of executive orders issued that relied on the existence of the Public Health Emergency expire as of July 4, 2021, with exceptions specified in the legislation.

Because Executive Order No. 192 (2020) is not specified in the legislation as continuing beyond July 4, 2021, masking, social distancing, and other health and safety protocols originally set forth in Executive Order No. 192 (2020) will no longer be mandatory across businesses and facilities, regardless if they are open to the public or not. Though these protocols are no longer required by the State, employers and entities overseeing worksites and other facilities are permitted to craft more restrictive policies that require masking and social distancing, and which continue the implementation of health and safety protocols.

Per Centers for Disease Control (CDC) Order, masks are required on planes, buses, trains, and other forms of public transportation traveling into, within, or out of the United States and in U.S. transportation hubs such as airports and stations. Travelers are not required to wear a mask in outdoor areas of a conveyance. Masking requirements also remain in effect in certain state-regulated settings, including child care facilities, camps, long-term care facilities, other healthcare settings, homeless shelters, and prisons. These masking requirements, which are consistent with CDC guidance, are included in Executive Order No. 242 (2021), which remains in effect under Section 1(14) of P.L.2021, c.103.

The majority of State offices open to the public, including New Jersey Motor Vehicle Commission locations, continue to require masking of staff and visitors. Individuals should review setting-specific requirements in advance of arrival.
