

As reported, this bill requires a public utility and local utility to notify, in a form and manner determined by the public utility and local utility, respectively, each of its residential customers of information and resources available to residential customers concerning utility service and bill payment assistance during the coronavirus 2019 pandemic. The notices required by the bill would have to contain information on any: 1) moratorium in effect on the disconnection, discontinuance, or termination of utility service; 2) deferred bill payment agreement program; 3) bill payment assistance program; and 4) arrearage forgiveness program. The notices are to be provided on a quarterly basis until 18 months after the date of the termination of Executive Order No. 103 of 2020, which authorized the State of Emergency in response to the coronavirus 2019 pandemic.

The bill requires the Department of Community Affairs, in consultation with the Board of Public Utilities, to compile information on State and federal policies and programs concerning public utility and local utility service and bill payment assistance, which is to be made available to every public utility and local utility and is to be included in the notices required by the bill.

The Senate Economic Growth Committee reports favorably and with committee amendments Assembly Bill No. 4671.

As amended and reported, this bill requires a public utility and local utility to notify, in a form and manner determined by the public utility and local utility, respectively, each of its residential customers of information and resources available to residential customers concerning utility service and bill payment assistance during the coronavirus 2019 pandemic. The notices required by the bill would have to contain information on any: 1) moratorium in effect on the disconnection, discontinuance, or termination of utility service; 2) deferred bill payment agreement program; 3) bill payment assistance program; 4) arrearage forgiveness program; and 5) moratorium in effect on rate increases or on the imposition of late fees, interest, or liens for late payments. This information also is to be published prominently on the public utility and local utility websites.

The bill's provisions are not to be construed as permitting a local utility from establishing or administering a bill payment assistance program that is not permitted by law.

The committee amended the bill to include information about any moratorium in effect on rate increases or on the imposition of late fees, interest, or liens for late payments in the required notice, to change the notification frequency from quarterly to match regular billing frequency, to require the notice to be provided in the same manner as regular bills, and to also require the information to be provided on public utility and local utility websites. Finally, the amendments remove a provision requiring the Department of Community Affairs and Board of Public Utilities to compile a list of State and federal bill payment assistance programs and for the public utilities and local utilities to distribute that information to their customers in the notifications required under this bill. A replacement provision provides that nothing in the bill is to be construed as permitting a local utility from establishing or administering a bill payment assistance program that is not permitted by law.

As amended and reported, Assembly Bill No. 4671 is identical to Senate Bill No. 3326, which was also reported and amended by the committee on this date.

The floor amendments also require that, for a municipality served by a public utility or local utility in which the primary language of 10 percent or more of the population is a language other than English, the public utility or local utility is to provide notification in that other language or languages for use by customers in that municipality.

This information is to be published prominently on the public utility and local utility websites.

The bill's provisions are not to be construed as permitting a local utility from establishing or administering a bill payment assistance program that is not permitted by law.

The committee amended the bill to include information about any moratorium in effect on rate increases or on the imposition of late fees, interest, or liens for late payments in the required notice, to change the notification frequency from quarterly to match regular billing frequency, to require the notice to be provided in the same manner as regular bills, and to also require the information to be provided on public utility and local utility websites. Finally, the amendments remove a provision requiring the Department of Community Affairs and Board of Public Utilities to compile a list of State and federal bill payment assistance programs and for the public utilities and local utilities to distribute that information to their customers in the notifications required under this bill. A replacement provision provides that nothing in the bill is to be construed as permitting a local utility from establishing or administering a bill payment assistance program that is not permitted by law.

As amended and reported, Senate Bill No. 3326 is identical to Assembly Bill No. 4671, which was also reported and amended by the committee on this date.

A-740/S-2846 (Johnson, Conaway, DeCroce/Gopal, Singleton) – Requires State agencies in awarding contracts for purchase of items that require power source to consider items powered by fuel cells

A-3384/S-3171 (McKeon/Pou) – Makes various revisions to "Uniform Fraudulent Transfer Act"; renames act to "Uniform Voidable Transactions Act"

A-4240/S-2855 (Downey, Vainieri Huttle, Houghtaling, Coughlin/Pou, Turner) – Provides for technological upgrade of application process for Supplemental Nutrition Assistance Program

A-4246/S-3175 (Verrelli, Benson, Vainieri Huttle/Pou, Corrado) – Permits expedited licensure in mental health professions for certain individuals during state of emergency or public health emergency

A-4477/S-2789 (Chiaravalloti, Conaway, Downey/Vitale, Weinberg) – Revises licensure, operational, and reporting requirements for nursing homes

ACS for A-4556 and 4145/S-2611 (Karabinchak, Zwicker, Quijano/Smith, Bateman) – Requires BPU to establish and maintain electronic public document search system on its website; requires BPU to provide certain notice of its meetings and hold quarterly public comment meetings

A-4671/S-3326 (Schaer, Swain, Tully/Ruiz, Singleton) – Requires public and local utilities to provide notice to residential customers of available relief measures during coronavirus disease 2019 pandemic

ACS for A-4805/SCS for S-3169 (Freiman, Tully, Danielsen/Pou, Gopal) – Requires certain insurers to provide summary concerning business interruption insurance

A-4806/S-3188 (Dancer, Chiaravalloti/Pou, Singleton) – Permits municipalities to authorize programs encouraging local shopping through property tax rewards; validates certain related municipal actions

A-4932/S-3066 (Johnson, Murphy, Downey/Pou) – Permits use of alternate names by limited liability partnerships

A-5222/S-3306 (Mukherji, Verrelli, Lopez/Diegnan, Turner) – Authorizes optometrists to administer immunizations against coronaviruses and influenza under certain circumstances
