

COMMITTEE AMENDMENTS:

The committee amendments provide that the annual cost-of-living increase that is applied to PAAD and Senior Gold income eligibility limits under current law will not apply in 2022, but will resume in 2023, and will continue to be increased annually each year thereafter.

FISCAL IMPACT:

The FY 2022 Budget Recommendation proposes expending an additional \$6.9 million to raise the Pharmaceutical Assistance to the Aged and Disabled (PAAD) income limits to \$38,769 for single persons and \$45,270 combined income for married couples beginning

on January 1, 2022. The annualized cost would therefore be \$13.8 million.

The Office of Legislative Services (OLS) does not concur with this Executive estimate; rather, the OLS estimates that the State will experience an \$11.0 million increase in costs due to a one-time increase of \$10,000 in the income eligibility limits established in the PAAD program and the Senior Gold Program. Following December 31, 2022, any increase in income eligibility under these programs, as well as the costs associated with those increases, will be the result of an existing statutory cost-of-living adjustment. As such, those costs are not attributed to this bill.

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that this bill will increase State expenditures by \$11.0 million between January 1, 2022 and December 31, 2022 as a result of a one-time increase of \$10,000 in the income eligibility limits established in the PAAD program and the Senior Gold Program. The estimate assumes that the threshold increase will bring an additional 19,093 enrollees into the PAAD program, as estimated by the department, and 2,144 enrollees into the Senior Gold Program, and utilizes cost data for the PAAD program and the Senior Gold program provided by the department on page D-196 of the Governor's FY 2022 Budget Recommendation. Of the \$11.0 million, \$10.6 million is attributed to the PAAD program, and \$400,000 is attributed to the Senior Gold program. Following December 31, 2022, any increase in income eligibility under these programs will be the result of an existing statutory COLA. As such, those costs are not attributed to this bill.

TRENTON – Today, Governor Phil Murphy signed the following bills into law.

A-13/S-4000 (Freiman, Armato, Pintor Marin, Mazzeo, Houghtaling, Coughlin/Sarlo, Sweeney, Addiego) – Establishes "New Jersey Debt Defeasance and Prevention Fund," appropriates \$3.7 billion.

S-1255/A-1925 (Singleton, Pou/Wimberly, Reynolds-Jackson, Tucker) - Requires that certain realty transfer fee revenues be dedicated to the Special Needs Housing Trust Fund.

S-3949/A-5871 (Sarlo, Cunningham/Pintor Marin, Burzichelli) – FY 2021 State supplemental appropriation; appropriates \$100.3 million in General Fund monies and \$14.4 million in Property Tax Relief Fund monies.

A-12/S-3997 (Coughlin, McKeon, Jasey, McKnight, Chiaravalloti/Addiego, Cunningham) – "New Jersey College Affordability Act"; appropriates \$10 million.

A-5539/S-3954 (Burzichelli, Benson, Zwicker/Sarlo, Sweeney) – Provides partial pension and retirement income exclusion for taxpayers with incomes between \$100,000 and \$150,000.

A-5345/S-3428 (Reynolds-Jackson, Mukherji, Vainieri Huttle/Lagana, Ruiz) — Expands eligibility under New Jersey earned income tax credit program to allow taxpayers who are at least 18 years of age or older to qualify for modified benefit.

A-5520/S-3633 (Vainieri Huttle, McKnight, Benson/T. Kean, Diegnan) – Increases income eligibility limits for PAAD program and Senior Gold Prescription Discount Program by \$10,000.

S-3798/A-5805 (Vitale, Turner/Lopez, Benson, Johnson) – Eliminates premiums and waiting periods for certain NJ FamilyCare enrollees and directs DHS to implement additional targeted outreach initiatives to increase enrollment.
