STATEMENT

The Legislature by chapter 234 of the laws of 1967 created a Division of Medical Examination in the State Department of Law and Public Safety and established the office of state medical examiner and of county medical examiner. The county offices of coroner, county physician and chief medical examiner are abolished. The purpose of this act is to conferm the prior law to chapter 234 of the laws of 1967.
