SPONSOR'S STATEMENT

This bill repeals sections of Title 45 and 52 of the Revised Statutes. The subject matter of these sections deals with professional and occupational boards. Because the reason advanced for repeal is not similar for all the statutes this bill has been divided into six sections. The reasons for repeal are:

Section 1. The statutes repealed by this section deal with standards for revocation, suspension and other disciplinary sanctions for professional and occupational boards within the Division of Consumer Affairs in the Department of Law and Public Safety. The boards' investigative, enforcement or penalty powers have either been superseded or repealed by passage of P. L. 1978, c. 73 (C. 45:1-14 et seq.).

The chapters affected in Titles 45 and 52 are: Chapter 2B (Certified Public Accountants), Chapter 3 (Architects), Chapter 4 (Barbers), Chapter 4A (Beauty Culture), Chapter 5 (Chiropody), Chapter 5A (Electrical Contractors), Chapter 6 (Dentists), Chapter 7 (Mortuary Science), Chapter 8 (Engineers), Chapter 8B (Marriage Counsellors), Chapter 9 (Medical Examiners), Chapter 9A (Hearing Aid Dispensers), Chapter 9B (Acupuncture), Chapter 10 (Midwifery), Chapter 11 (Nursing), Chapter 12 (Optometry), Chapter 12A (Orthoptics), Chapter 14 (Pharmacy), Chapter 14A (Planners), Chapter 14B (Psychologists), Chapter 14C (Plumbers), Chapter 15B (Shorthand Reporters), Chapter 16 (Veterinary Medical Examiners) and Chapter 17B in Title 52 (Ophthalmic Dispensers and Technicians).

Section 2. The statutes repealed in this section deal with licensing, application or other regulatory fees of professional or occupational boards. These provisions have been superseded by passage of P. L. 1974, c. 46 (C. 45:4-35.2).

The chapters affected in Titles 45 and 52 are: Chapter 4 (Barbers), Chapter 4A (Beauty Culture), Chapter 6 (Dentists), Chapter 8B (Marriage Counsellors), Chapter 10 (Midwifery), Chapter 11 (Nursing), Chapter 12A (Orthoptics), Chapter 14 (Pharmacy), Chapter 14B (Psychologists), Chapter 15B (Shorthand Reporters) and Chapter 17B in Title 52 (Opthalmic Dispensers and Technicians).

Section 3. The statutes repealed in this section deal with the powers of professional and occupational boards to employ inspectors and other clerical employees. These sections have been superseded by P. L. 1971, c. 134, s. 4 (C. 52:17B-121).

The chapters affected in Title 45 are Chapter 4A (Beauty Culture), Chapter 7 (Mortuary Science), Chapter 9 (Medical Examiners) and Chapter 14 (Pharmacy).

Section 4. The statutes repealed in this section impose a requirement of citizenship as a requirement to obtain a license or sit for a license examination. The Attorney General by F. O. No. 10 (1974) concluded such conditions to be invalid under prior decisions of the United States Supreme Court.

The chapters affected in Title 45 are: Chapter 1 (General Provisions) and Chapter 3 (Architects).

Section 5. The statutes repealed by this section required the performance of an act or acts within a specified time. The time within which the act or acts were to be performed or the date by which they were to be performed has expired.

The chapters affected in Title 45 are: Chapter 5A (Electrical Contractors), Chapter 7 (Mortuary Science), Chapter 8B (Marriage Counsellors), Chapter 9 (Medical Examiners), Chapter 14A (Planners), Chapter 14B (Psychologists) and Chapter 15B (Shorthand Reporters).

Section 6. The statutes repealed by this section have become unnecessary or archaic and should be repealed.

This bill provides for the repeal of certain outmoded sections of law. The Senate Labor, Industry and Professions Committee amended section 2 of the bill which repeals statutes supposedly superseded by the passage of P. L. 1974, c. 46 (C. 45:4-35.2).

P. L. 1974, c. 46 is permissive. It provides that the professional boards and commissions enumerated in the act "may," by regulation, change their charges for examination, licensures and other regulatory fees. Some of the enumerated boards and commissions, however, have not chosen to make these changes. They are still proceeding pursuant to prior statutes, which therefore should not be repealed.

The section headnotes which were prepared by either the Office of the Secretary of State or West Publishing Co. and are used in the New Jersey Statutes Annotated have been listed in the committee statement to provide a clear indication of the content of the sections being repealed. Because the reason advanced for repeal is not similar for all the statutes this bill has been divided into six sections. The reasons for repeal are:

Section 1. Governor Brendan Byrne has signed the following bills into law:

S-3273, sponsored by Senator Eugene J. Bedell (D-Monmouth), which repeals various sections of Title 45 and 52, dealing with the professional and occupational boards.

The statutes repealed deal with standards for revocations, suspension and other disciplinary sanctions, as well as fees, for professional and occupational boards within the Division of Consumer Affairs in the Department of Law and Public Safety. The boards' investigative, enforcement and penalty powers have either been superseded or repealed.

S-3324, sponsored by Senator Joseph P. Merlino (D-Mercer), which changes the title of the County Superintendent of Public Works to the County Superintendent of Buildings and Grounds. It also increases the term of the Superintendent from three to five years.

The rationale for the bill is that the title of Superintendent of Public Works was created many years ago, but no longer reflects the present structure of government.

Under the Optional County Charter Law, some county governments now have Division Directors of Public Works with subordinate superintendents of various specialties, such as buildings and grounds, bridges and roads. This bill more accurately reflects the scope of the position.

S-3266, sponsored by Senator William V. Musto (D-Hudson), which repeals the "Interim Legislative District and Apportionment Act of 1965."

The provisions of the "Interim Legislative District and Apportionment Act of 1965" applied only to the Legislature elected in November of 1965 for legislative year 1965 for legislative years 1966 and 1967. An Apportionment Commission established pursuant to a Constitutional amendment approved in November of 1966 is now responsible for determining legislative districts.
