P.L. 1997, CHAPTER 68, *approved April 16, 1997* Senate, No. 1540

1 AN ACT concerning State psychiatric facilities and supplementing Title 2 30 of the Revised Statutes.

BE IT ENACTED by the Senate and General Assembly of the State 5 of New Jersey:

1. As used in this act:

"Clinical treatment staff" means a physician, psychiatrist, psychologist, physical therapist or social worker licensed pursuant to Title 45 of the Revised Statutes, an occupational, recreation, art or music therapist or a substance abuse counselor.

"Nursing direct care staff" means a Human Services Assistant, Human Services Technician or a nurse licensed pursuant to Title 45 of the Revised Statutes.

- 2. a. The Commissioner of Human Services shall designate staff who are not employed at a State psychiatric facility listed in R.S.30:1-7 to conduct unannounced site visits to randomly check staffing on various shifts at a State psychiatric facility, at least three times during a calendar year. During the site visit, the designated staff shall review: the daily operation of the facility, including, the actual deployment of clinical treatment staff and nursing direct care staff on various shifts to determine whether the actual deployment of staff meets the documented staffing plan of the facility; the system for reporting any information concerning alleged patient abuse or professional misconduct as provided for in P.L., c. (C.) (now pending before the Legislature as Senate Bill No. of 1996); the operation of therapeutic programs or activities for patients; and any other aspect of the facility which the commissioner deems appropriate.
- b. The commissioner shall provide and implement, on an ongoing basis, surveillance procedures designed to identify problems related to patient care at a State psychiatric facility. These procedures shall include, but not be limited to, the use of security cameras and the use of persons to perform covert investigations of the daily operation of the facility. Persons performing covert investigations shall assume roles which do not suggest their actual function.

The Assembly Community Services Committee reports favorably Senate Bill No. 1540.

This bill requires the Commissioner of Human Services to designate staff who are not employed at a State psychiatric facility listed in R.S.30:1-7 to review the daily operation of the State psychiatric facilities by conducting unannounced site visits to randomly check staffing on the various shifts at a State psychiatric facility, at least three times during a calendar year.

During the visit, the designated staff shall review:

- the actual deployment of clinical treatment staff and nursing direct care staff on various shifts to determine whether the actual deployment meets the documented staffing plan;
- the system for reporting any information concerning alleged patient abuse or professional misconduct;
- the operation of therapeutic programs of activities for patients; and
- any other aspect of the facility which the commissioner deems appropriate.

In addition, the bill requires the commissioner to provide and implement surveillance procedures, including but not limited to, the use of security cameras and the use of persons to perform covert investigations of the daily operation of the facility. Persons performing covert investigations shall assume roles which do not suggest their actual functions.

The Senate Human Services Committee reports favorably Senate Bill No. 1540.

This bill requires the Commissioner of Human Services to designate staff who are not employed at a State psychiatric facility listed in R.S.30:1-7 to review the daily operation of the State psychiatric facilities by conducting unannounced site visits to randomly check staffing on the various shifts at a State psychiatric facility, at least three times during a calendar year.

During the visit, the designated staff shall review:

- the actual deployment of clinical treatment staff and nursing direct care staff on various shifts to determine whether the actual deployment meets the documented staffing plan;
- the system for reporting any information concerning alleged patient abuse or professional misconduct pursuant to Senate Bill No. 1542 (Bassano/Codey) or Assembly Bill No. 2426 (Bucco/Murphy) of 1996;
- the operation of therapeutic programs of activities for patients;

- any other aspect of the facility which the commissioner deems appropriate.

In addition, the bill requires the commissioner to provide and implement surveillance procedures, including but not limited to, the use of security cameras and the use of persons to perform covert investigations of the daily operation of the facility. Persons performing covert investigations shall assume roles which do not suggest their actual functions.

This legislation is part of a package of bills which was recommended in the Final Report of the Senate Task Force on Greystone Park Psychiatric Hospital, June 1996, and is designed to improve the care provided in the State's psychiatric facilities. LEGISLATIVE FISCAL ESTIMATE TO

Bill Summary:

Senate Bill No. 1540 of 1996 requires the Commissioner of Human Services to designate staff who are not employed at a State psychiatric facility to review the daily operation of the State psychiatric facilities by conducting unannounced site visits to randomly check staffing on the various shifts at a State psychiatric facility, at least three times during a calendar year. The bill requires the commissioner to provide and implement surveillance procedures, including but not limited to, the use of security cameras and the use of persons to perform covert investigations of the daily operation of the facility.

Agency Comments:

The Department of Human Services (DHS) and the Office of Management and Budget have not provided any fiscal information on the legislation.

Office of Legislative Services Comments:

As there are seven State psychiatric facilities, at least 21 unannounced site visits would have to be conducted annually. The number of personnel and type of personnel that would be involved in such unannounced site visits are not known at this time, but as such personnel are likely to be reassigned from other DHS or other State agencies responsibilities, no new costs should be incurred. Similarly, having persons perform covert investigations of the daily operation of the facility would involve the reassignment of existing personnel to conduct such covert investigations and, thus, should not involve any new costs.

Using security cameras to implement surveillance procedures may require the purchase of additional security cameras. However, the cost associated with the purchase of and installation of additional cameras cannot be determined.

This legislative fiscal estimate has been produced by the Office of Legislative Services due to the failure of the Executive Branch to respond to our request for a fiscal note.
