1 AN ACT creating the ²[Upper]² Rahway River Intergovernmental
2 Cooperation Committee and supplementing Title 58 of the Revised
3 Statutes.

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

7

8 1. This act shall be known, and may be cited, as the " ²[Upper]²
9 Rahway River Intergovernmental Cooperation Committee Act."
10

11 2. The Legislature finds and declares that the ²[upper]² Rahway
12 river is an important natural, recreational, and economic resource
13 utilized and enjoyed by the citizens of the State; that the value of this
14 resource is heavily dependent upon water quality, and poor water
15 quality is a potential threat to the public health, safety, and welfare,
16 and to the environment; that the river has suffered in the past, and
17 continues to suffer, from abuse and neglect due to point and nonpoint
18 source pollution discharges, stormwater runoff, illegal dumping of
19 litter and other debris, and ²[other environmental and aesthetic insults]
20 is subject to flooding conditions, creating a threat to people and
21 property throughout the river system².

22 The Legislature therefore determines that it is appropriate for the
23 municipalities and counties within which the ²[upper]² Rahway river
24 is located to form an intergovernmental cooperative working group to
25 (1) develop recommended regional planning strategies and other
26 regional policies, procedures, and model ordinances and resolutions,
27 which would be implemented by each member municipality and county
28 on a voluntary basis, (2) where appropriate, coordinate efforts of
29 member municipalities and counties to clean up the ²[upper]² Rahway
30 river system or any tributary or watershed land thereof ²and to

20 environmental and aesthetic insults to the ²[upper]² Rahway river
21 system, or to otherwise maintain or enhance the environmental health
22 and water quality of the ²[upper]² Rahway river system or any
23 tributary or watershed land thereof.

24 "River counties" means Union county ², Middlesex county,² and
25 Essex county.

26 "River municipalities" means the Union county municipalities of
27 Clark, Cranford, Garwood, Kenilworth, ²Linden,² Mountainside,
28 Rahway, ²Scotch Plains,² Springfield, Summit, Union, Westfield, and
29 Winfield, ²the Middlesex county municipalities of Carteret, Edison,
30 and Woodbridge,² the Essex county municipalities of Maplewood,
31 Millburn, Orange, South Orange, and West Orange, and any other
32 Union ², Middlesex,² or Essex county municipality that chooses to
33 participate, and is accepted, as a member of the committee as provided
34 in section 4 of this act.

36 4. a. There is created the "²[Upper]² Rahway River

4 Any municipality in Union county ², Middlesex county,² or Essex
5 county that is not a river municipality may, through its governing
6 body, request membership, with full voting privileges, on the
7 committee. Such membership shall be granted upon a majority vote
8 of the voting membership of the committee.

9 b. Vacancies in the positions on the committee shall be filled in the
10 same manner as the original appointments were made.

11 c. Members of the committee shall serve without compensation,
12 but may, within the limits of funds appropriated or otherwise made
13 available to the committee, be reimbursed for actual expenses
14 necessarily incurred in the discharge of their official duties.

15 d. A member of the committee may be removed at any time for any
16 reason by the municipal or county governing body, ¹or the county
17 executive,¹ as the case may be, that appointed that member.

18

19 5. a. The committee shall organize as soon as may be practicable
20 after the appointment of its members and shall select a chairperson and
21 a vice-chairperson from among its members. The department shall
22 provide technical and planning assistance to the committee.

23 b. A majority of the voting membership of the committee shall
24 constitute a quorum for the transaction of committee business. Action
25 may be taken and motions and resolutions adopted by the committee
26 at any meeting thereof by the affirmative vote of a majority of the full
27 voting membership of the committee.

28 c. The committee shall meet regularly as it may determine, and
29 shall also meet at the call of the chairperson of the committee, the
30 commissioner, or the Governor.

31

32 6. In order to facilitate achievement of the State goal, as set forth
33 in this act, to fully restore, promote, preserve, and maintain the
34 environmental health and water quality of the ²[upper]² Rahway river
35 system, the committee shall:

36 a. develop recommended regional planning strategies and other
37 regional policies, procedures, and model ordinances and resolutions,
38 which would be implemented by each member municipality and county
39 on a voluntary basis;

40 b. where appropriate, coordinate efforts of member municipalities
41 and counties to clean up the ²[upper]² Rahway river system or any
42 tributary or watershed land thereof ²and to alleviate flooding
43 conditions in that river system²;

44 c. recommend appropriate State legislation and administrative

6 itself of the services of such employees of any State, county, or

10 staff or experts and incur such traveling and other miscellaneous
11 expenses as it may deem necessary in order to perform its duties, and
12 as may be within the limits of funds appropriated or otherwise made
13 available to it for those purposes.

15 8. The meetings of the committee shall be subject to the provisions
16 and requirements of the "Open Public Meetings Act," P.L.1975, c.231
17 (C.10:4-6 et seq.).

18
19 9. a. The committee shall report its findings and conclusions,
20 together with any recommendations for legislation or administrative
21 action to abate environmental threats to the ²[upper]² Rahway river
22 system or to otherwise further the State goal to fully restore, promote,
23 preserve, and maintain the environmental health and water quality of
24 that river system, ²and to alleviate flooding conditions in that river
25 system.² to the Governor, the Legislature, and the commissioner
26 within one year after the date of enactment of this act and periodically
27 as necessary thereafter.

28 b. The committee shall dissolve ten years after the date of
29 enactment of this act unless the voting membership of the committee
30 unanimously votes to continue its existence. Thereafter, such a vote
31 shall be held annually, and failing the receipt of a unanimous vote of
32 the voting membership to continue the existence of the committee for
33 another year, the committee shall thereupon dissolve.

The Assembly Environment, Science and Technology Committee reports favorably Assembly Bill No.665.

This bill would create the "Upper Rahway River Intergovernmental Cooperation Committee," which would be composed of: (1) a representative of each river municipality, who shall be selected by the governing body of that municipality and who shall be a voting member of the committee; (2) a representative of Union county, who shall be selected by the governing body of that county and who shall be a voting member of the committee; (3) a representative of Essex county, who shall be selected by the governing body of that county and who shall be a voting member of the committee; and (4) the Commissioner of Environmental Protection, or a designee thereof, who shall serve ex officio and who shall be a nonvoting member of the committee.

Any municipality in Union county or Essex county that is not a river municipality may, through its governing body, request membership, with full voting privileges, on the committee. Such membership would be granted upon a majority vote of the voting membership of the committee.

"River municipalities" is defined in this bill to mean the Union county municipalities of Clark, Cranford, Garwood, Kenilworth, Mountainside, Rahway, Springfield, Summit, Union, Westfield, and Winfield, the Essex county municipalities of Maplewood, Millburn, Orange, South Orange, and West Orange, and any other Union or Essex county municipality that chooses to participate, and is accepted, as a member of the committee as provided in section 4 of the bill.

In order to facilitate achievement of the State goal, as set forth in this bill, to fully restore, promote, preserve, and maintain the environmental health and water quality of the upper Rahway river system, the committee would be required to:

(1) develop recommended regional planning strategies and other regional policies, procedures, and model ordinances and resolutions, which would be implemented by each member municipality and county on a voluntary basis;

(2) where appropriate, coordinate efforts of member municipalities and counties to clean up the upper Rahway river system or any

tributary or watershed land thereof;

(3) recommend appropriate State legislation and administrative action; and

(4) advocate, and where appropriate, act as a coordinating, distributing, or recipient agency for, federal and State funding of environmental protection projects in river municipalities and river counties, which projects may include the work of the committee.

This bill provides that the committee would dissolve in ten years unless the committee on an annual basis decides by unanimous vote to continue.

Under the bill the Department of Environmental Protection would provide technical and planning assistance to the Upper Rahway River Intergovernmental Cooperation Committee.

This bill was pre-filed for introduction in the 1996-1997 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

The Senate Community Affairs Committee reports favorably Assembly, No. 665 (1R) with committee amendments.

This bill, as amended, would create the "Rahway River Intergovernmental Cooperation Committee," which would be composed of: (1) a representative of each river municipality, who shall be selected by the governing body of that municipality and who shall be a voting member of the committee; (2) a representative of Union county, who shall be selected by the governing body of that county and who shall be a voting member of the committee; (3) a representative of Middlesex County, who shall be selected by the governing body of that county and who shall be a voting member of the committee; (4) a representative of Essex county, who shall be selected, and may be removed, by the county executive of that county and who shall be a voting member of the committee; and (5) the Commissioner of Environmental Protection, or a designee thereof, who shall serve ex officio and who shall be a nonvoting member of the committee.

Any municipality in Union county or Essex county that is not a river municipality may, through its governing body, request membership, with full voting privileges, on the committee. Such membership would be granted upon a majority vote of the voting membership of the committee.

"River municipalities" is defined in this bill to mean the Union county municipalities of Clark, Cranford, Garwood, Kenilworth, Linden, Mountainside, Rahway, Scotch Plains, Springfield, Summit, Union, Westfield, and Winfield, the Middlesex county municipalities of Carteret, Edison, and Woodbridge, the Essex county municipalities of Maplewood, Millburn, Orange, South Orange, and West Orange, and any other Union, Middlesex, or Essex county municipality that chooses to participate, and is accepted, as a member of the committee as provided in section 4 of the bill.

In order to facilitate achievement of the State goal, as set forth in this bill, fully to restore, promote, preserve, and maintain the

environmental health and water quality of the Rahway river system, the committee would be required to:

(1) develop recommended regional planning strategies and other regional policies, procedures, and model ordinances and resolutions, which would be implemented by each member municipality and county on a voluntary basis;

(2) where appropriate, coordinate efforts of member municipalities and counties to clean up the Rahway river system or any tributary or watershed land thereof and to alleviate flooding conditions in that river system;

(3) recommend appropriate State legislation and administrative action; and

(4) advocate, and where appropriate, act as a coordinating, distributing, or recipient agency for, federal and State funding of environmental protection projects in river municipalities and river counties, which projects may include the work of the committee.

This bill provides that the committee would dissolve in ten years unless the committee on an annual basis decides by unanimous vote to continue.

Under the bill, the Department of Environmental Protection would provide technical and planning assistance to the Rahway River Intergovernmental Cooperation Committee.

The committee amended the bill to add a representative from Middlesex county to the river committee; to add the Middlesex county municipalities of Carteret, Edison, and Woodbridge, and the Union county municipalities of Linden and Scotch Plains to the bill's definition of "river municipalities"; and to establish as a goal, where appropriate, the alleviating of flooding conditions in that river system. The committee also amended the bill to remove the word "upper" from the name of the river committee to reflect more accurately the scope of the bill.

STATEMENT TO
ASSEMBLY, No. 665

with Assembly Floor Amendments
(Proposed By Assemblyman WEINGARTEN)

ADOPTED: SEPTEMBER 26, 1996

This amendment specifies that the representative of Essex county to the Upper Rahway River Intergovernmental Cooperation Committee shall be selected by the county executive of Essex county and may be removed by the county executive of that county.

LEGISLATIVE FISCAL ESTIMATE TO

Assembly Bill No. 665 of 1996 creates the Upper Rahway River Intergovernmental Cooperation Committee for the purpose of fully restoring, promoting, preserving, and maintaining the environmental health and water quality of the upper Rahway river system. The committee is charged with achieving these goals by developing regional planning strategies, coordinating cleanup efforts, recommending State legislation, and acting as the lead agency for receiving or distributing public monies for environmental protection projects that affect the river. The bill specifies the composition and the responsibilities of the committee, and directs the Department of Environmental Protection (DEP) to provide technical and planning assistance as needed.

The Office of Legislative Services estimates that the bill will have no significant impact on local budgets, nor on the operating budget, staff or resources of the DEP because the participation level of the committee members and the DEP will likely be governed by the budgetary limitations of the participants (unless other funding sources are made available). The long-term fiscal impact of the bill on the local and State economies should be positive if the upper Rahway River is improved to the point where significant revenues can be generated from tourism and recreational opportunities initiated under the committee's direction.

This legislative fiscal estimate has been produced by the Office of Legislative Services due to the failure of the Executive Branch to respond to our request for a fiscal note.
