The Assembly Appropriations Committee reports favorably Assembly Bill No. 2457.

Assembly Bill No. 2457 allows the State to recover reasonable costs of suit, including attorneys' and filing fees, for successful actions brought by the Attorney General under the consumer fraud law. While currently the court may award costs of suit to private litigants who successfully sue for damages, the State absorbs its court costs when it brings a damage suit for consumer fraud. This bill would provide the State with the same opportunity for recovery of such costs as is afforded to private litigants.

#### FISCAL IMPACT:

The Division of Consumer Affairs has provided the information that the division and the Office of Administrative Law spent about \$1.25 million in costs qualifying for reimbursement in the most recent year for which information is available.

Assembly Bill No. 2457 of 1996 permits the State to recover reasonable costs of suits, including attorneys' and filing fees, for successful actions brought by the Attorney General under the consumer fraud law. Under current law, the court may award costs of suit to private litigants who successfully sue under the consumer fraud law, but not to the State.

Information provided informally by the Division of Consumer Affairs in the Department of Law and Public Safety indicates that approximately \$1,250,000 in costs would have been reimbursed to the State under this bill in the most recent year for which this information is available. This figure is comprised of approximately \$750,000 for legal services provided by the Division of Law and approximately \$500,000 in preliminary costs incurred by the Office of Administrative Law.

The Office of Legislative Services observes that the volume of court-awarded reimbursements following enactment of this bill cannot be accurately estimated. However, if the State's prosecutorial effort continues at its current level, reimbursements to the State may approximate current costs and increase with inflation in future years.

This fiscal estimate has been prepared pursuant to P.L.1980, c.67.
