## STATE OF NEW JERSEY

DATED: DECEMBER 11, 1997

The Assembly Law and Public Safety Committee reports favorably Senate Bill No. 1235 (1R).

Senate Bill No. 1235 (1R) supplements chapter 3 of Title 39 of the Revised Statutes to require that motorists who are stopped by law enforcement officers at night, or during other times when visibility is hampered and headlights are required to be turned on, to turn on an interior light to illuminate the driver's compartment of the motor vehicle whenever requested to do so by the officer. The bill also requires that a \$50 fine be imposed on any driver who "purposely" refuses comply to with the law.

Senate Bill No. 1235 (1R) is identical to Assembly Bill No. 701, as amended by the committee.

The Senate Law and Public Safety Committee reports favorably and with committee amendments Senate Bill No. 1235.

As amended and released by the committee, this bill requires motorists who are stopped by police at night or during times when visibility is hampered, to turn on an interior light at the request of the police officer to illuminate the driver's compartment of the motor vehicle. The bill also requires that the \$50 fine be imposed on any person who "purposely" refuses to comply with the requirements of the law.

The committee amended the bill to require that the light be activated only upon the officer's request. The other committee amendment is technical in nature.
