5 **BE IT ENACTED** by the Senate and General Assembly of the State of New Jersey:

1. There is established the Miss New Jersey Educational Scholarship program. It shall be the duty of the <sup>2</sup>[Student Assistance Board, established pursuant to P.L.1977, c.330 (C.18A:71-15.1 et seq.)] Office of Student Assistance established pursuant to section 17 of P.L.1994, c.48 (C.18A:3B-17)<sup>2</sup> to administer this program.

A Miss New Jersey Educational Scholarship shall be awarded 14 <sup>2</sup>[to any] annually to an<sup>2</sup> individual who has been designated <sup>2</sup>[as 15 Miss New Jersey and who has represented this State in the Miss 16 17 America Pageant by the Office of Student Assistance, in consultation 18 with the Miss New Jersey Pageant Organization, as being an 19 exceptional young leader in the area of civic, cultural or charitable 20 endeavors in the spirit of the Miss New Jersey Pageant. # STATE OF NEW JERSEY

DATED: MAY 13, 1996

The Assembly Education Committee favorably reports Assembly Bill No. 921 with committee amendments.

As amended by committee, this bill establishes the Miss New Jersey Educational Scholarship Program. The bill provides that any individual who has been named Miss New Jersey and who represents this State in the Miss America Pageant will be entitled to receive an initial bachelors degree or post graduate degree at any public institution of higher education of this State without payment of tuition as long as the student remains a full time student in good standing at the institution.

The committee amended the bill to permit a scholarship recipient to pursue either a post graduate degree or an initial undergraduate degree. The amendment addresses those situations in which a Miss New Jersey has already attained a bachelors degree or is close to receiving one.

This bill was prefiled for introduction in the 1996 legislative session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

ASSEMBLY BILL NO. 921 (First Reprint)

To the General Assembly:

Pursuant to Article V, Section I, Paragraph 14 of the New Jersey Constitution, I am returning Assembly Bill No. 921 (First Reprint) with my recommendations for reconsideration.

#### A. Summary of Bill

This bill establishes the Miss New Jersey Educational Scholarship Program to be administered by the Student Assistance Board. The bill will allow any Miss New Jersey, who represents the State in the Miss America Pageant, to receive an initial bachelors degree or post graduate degree without payment of tuition at any public institution of higher education in the State.

The intent of the sponsors of the legislation, in recognizing the contributions of the Miss New Jersey and Miss America Pageants in promoting the State of New Jersey, is laudable. The economic benefits brought to the people of New Jersey by these pageants is also significant. I believe, however, that the leadership, cultural and civic qualities recognized by these pageants are held by young people throughout the State engaged in many different endeavors. These young leaders should also be eligible to compete for a scholarship and to have their contributions recognized.

#### B. Recommended Action

I propose that the Miss New Jersey Educational Scholarship Program established by the bill be open to any exceptional young leader in the State who is involved in civic, cultural or charitable endeavors in the State. The Office of Student Assistance, in

consultation with the Miss New Jersey Pageant Organization, will designate one such individual annually to receive the scholarship. However, the first scholarship will be awarded to the reigning Miss New Jersey in order to emphasize the qualities on which the scholarship program is founded. In this way, the spirit of the Miss New Jersey Pageant will be commemorated, while annually recognizing the contributions made by an exceptional young leader in the State.

The people of the State of New Jersey should be proud of the accomplishments of its youth and this bill, with my proposed amendments, will allow us to recognize and reward their accomplishments with the hope of encouraging other young people to follow their example.

Therefore, I herewith return Assembly Bill No. 921
(Firs Reprint) and recommend that it be amended as follows:
