An Act concerning counties, municipalities, or agencies thereof in relation to certain group insurance programs and amending N. J. S. 40A:10-17 and N. J. S. 40A:10-19.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. N. J. S. 40A:10-17 is amended to read as follows:
- 2 40A:10-17. Contracts for group insurance. Any local unit or
- 3 agency thereof, herein referred to as employers, may:
- 4 a. Enter into contracts of group life, accidental death and
- 5 dismemberment, hospitalization, dental, medical, surgical, major
- 6 medical expense, or health and accident insurance with any in-
- 7 surance company or companies authorized to do business in this
- 8 State, or may contract with a nonprofit hospital service or medical
- 9 service or dental service corporation with respect to the benefits
- 10 which they are authorized to provide respectively. The contract
- 11 or contracts shall provide any one or more of such coverages for
- 12 the employees of such employer and may include their dependents;
- b. Enter into a contract or contracts to provide drug prescrip-
- 14 tion and other health care benefits, or enter into a contract or con-
- 15 tracts to provide drug prescription and other health care benefits
- 16 as may be required to implement a duly executed collective negotia-
- 17 tions agreement, or as may be required to implement a determina-
- 18 tion by a local unit to provide such benefit or benefits to employees
- 19 not included in collective negotiations units.
- 20 Nothing herein contained shall be deemed to authorize coverage
- 21 of dependents of an employee under a group life insurance policy
- 22 or to allow the issuance of a group life insurance policy under
- 23 which the entire premium is to be derived from funds contributed
- 24 by the insured employees.
- 2. N. J. S. 40A:10-19 is amended to read as follows:
- 2 40A:10-19. Limitations, exclusions, exceptions to be contained
- 3 in contract. Any contract or contracts permitted under this sub-

- 4 article shall contain limitations, exclusions or exceptions so as to
- 5 avoid duplication of benefits or services otherwise available pur-
- 6 suant to accidental death and dismemberment, hospitalization,
- 7 dental, medical, surgical, major medical expense, or health and
- 8 accident coverage under any other law of this State or the coverage
- 9 afforded under the laws of the United States, such as the Federal
- 10 Medicare Program, and at the option of the employer and the

Assembly Bill No. 1433 would permit counties and municipalities, and their agencies, to contract for dental insurance programs for their employees with insurance companies, or with nonprofit dental service corporations.

The State is currently authorized to extend dental coverage to State employees. Many local governments have negotiated dental coverage with their own employees, absent any explicit statutory authorization.
