DATED: MARCH 7, 1996

The Senate Community Affairs Committee reports favorably Senate, No. 513 with committee amendments.

This bill, as amended, would eliminate the county office of register of deeds and mortgages in a county of the second class with a population density greater than 4,500 persons per square mile and a population between 490,000 and 505,000 according to the most recent federal decennial census. Union County is the only county that meets these criteria.

As amended, the bill provides that the office of register of deeds and mortgages would be consolidated with the office of county clerk upon the expiration of the term of office of the current register of deeds and mortgages or the occurrence of a vacancy prior to the expiration of that term of office, whichever occurs first. The bill also provides that upon consolidation of the office of register of deeds and mortgages with the county clerk, the office of register of deeds and mortgages would be abolished and the powers, functions, and duties of that office will be given to the county clerk.

LEGISLATIVE FISCAL ESTIMATE TO

Senate Bill No. 513 (1R) would consolidate the office of the register of deeds and mortgages in Union county with the office of the county clerk. The office of the register of deeds and mortgages was created in Union county by a legislative mandate in 1904.

The Office of Legislative Services (OLS) has been advised by the Union County clerk that the consolidation of these two offices would save Union County at least \$100,000 this year. It is anticipated that next year, the full-year savings will exceed this year's savings by several thousand dollars, but the clerk was unable to provide a specific figure at this time.

The Office of Legislative Services has no information that would indicate cost cavings other than those indicated by the clerk.

The logislative discal estimate has been produced by the Office of Legislative Services due to the failure of the Executive Branch to respond to our request for a fiscal note.

This fiscal estimate has been prepared pursuant to P.L.1980, c.67.

Gov. Christie Whitman has signed legislation extending the reemployment period for hiring laid-off law enforcement officers. She also signed a bill eliminating the office of register of deeds and mortgages in Union County.

A-1683/S-70, increases from 36 to 60 months the period during which laid-off law enforcement officers are eligible for reemployment appointments under the state's special statewide law enforcement program.

Current law requires that the names of qualified law enforcement officers who are laid off for economic reasons are placed on a special reemployment list which is circulated by the Department of Personnel to local hiring authorities. The officers on list however are only eligible for reemployment during the first 36 months of their layoff. This legislation extends the eligibility period to 60 months to assist officers who did not find employment during the 36-month period.

The bill was sponsored by Assemblywoman Diane Allen and Assemblyman Carmine DeSopo (both R-Burlington/Camden) and Senators Jack Casey (D-Burlington/Camden) and Louis Kosco (R-Bergen).

S-513/A-606, consolidates the office of register of deeds and mortgages in Union County with the office of the county clerk. Because the state has, by constitutional amendment and law, recently assumed responsibilities and costs for certain parts of the judicial system, the county clerk has been relieved of certain responsibilities and is now in a position to assume those of the register of deeds and mortgages. The office of the register of deeds and mortgages was created in Union County by a legislative mandate so legislation, rather than action by the county, is required to abolish the office.

The bill was sponsored by Senator Louis Bassano (R-Essex/Union) and the late Assemblyman Monroe Jay Lustbader (R-Essex/Union).
