1	AN ACT concerning the use of firearms while trapping on Sundays and

4	BE IT ENACTED by the Senate and General Assembly of the State
5	of New Jersey:

7	1. R.S.23:4-24 is amended to read as follows:
8	23:4-24. No person shall hunt with a hound or with firearms or
9	weapons of any kind, or carry a gun in the woods or fields or on the
10	waters on Sunday, under a penalty of \$20.00 for each offense; except
11	that this section shall not apply to any person hunting raccoon between
12	midnight on Saturday and sunrise on Sunday during the season
13	prescribed in section 23:4-1 of this Title or to a person possessing a
14	valid and proper rifle permit licensed to trap fur-bearing animals
15	pursuant to the provisions of R.S.23:3-1 using a .22 caliber rifle and
16	.22 caliber short rimfire cartridges to humanely dispatch legally
17	trapped animals. This section shall not prevent farm land owners,
18	lessees actually occupying or farming the land, members of their

The Senate Law and Public Safety Committee reports favorably Senate Bill No. 720. This bill permits persons licensed to trap fur-bearing animals under R.S.23:3-1 to use a .22 caliber rifle with .22 caliber short rimfire cartridges to shoot and kill legally trapped animals on Sundays. The bill requires the animal be killed in a humane manner.

Under current law, trapping is permitted every day of the week and the use of firearms in the field is permitted every day except Sundays. Consequently, trappers are unable to dispatch trapped animals on Sundays in the most humane fashion, which is with a firearm. Under the provisions of the bill, trappers would be able to use firearms and ammunition of limited power on Sundays only for that purpose.
