1 AN ACT concerning the appointment of a superintendent and

The Assembly State Government Committee reports favorably Assembly Bill No. 534.

This bill authorizes the Palisades Interstate Park Commission to appoint persons qualified by training and experience to the positions of superintendent and assistant superintendent and assigns those positions to the State unclassified service. The bill authorizes the commission to remove anyone appointed to these positions after notice and an opportunity to be heard.

This bill was pre-filed for introduction in the 1994 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.

The Senate State Management, Investments and Financial Institutions Committee reports favorably Assembly, No. 534.

This bill provides for the reclassification of the positions of Superintendent and Assistant Superintendent of the Palisades Interstate Park Commission from the career service to the unclassified service. The commission shall appoint persons qualified by training and experience to these positions. The commission may remove anyone appointed to these positions after notice and an opportunity to be heard.
