1 AN ACT concerning the salaries of council aides in certain cities
2 and amending P.L.1973, c.89.

4 BE IT ENACTED by the Senate and General Assembly of the
5 State of New Jersey:

6 1. Section 1 of P.L.1973, c.89 (C.40:69A-60.5) is amended to
7 read as follows:

8 1. The municipal council of any municipality having a
9 population of more than 270,000 which, prior to January 9, 1982
10 had adopted the form of government designated as
11 "Mayor-Council Plan C" provided for in article 5 of P.L.1960,
12 c.210 (C.40:69A-55 et seq.), may appoint an executive secretary
13 and not more than four aides for each council member, who shall
14 serve, and be removable at the pleasure of the council member,
15 and who shall serve in the unclassified service of the civil service
16 of the city and shall receive such salary as shall be fixed by
17 ordinance, but said salary shall not exceed the salaries of persons
18 holding the positions of executive secretary or aide on April 26,
19 1985. Persons appointed pursuant to this section may have their
20 salaries increased on a periodic basis in accordance with the
21 recommendation in an annual merit evaluation for each aide, to
22 be filed with the municipal clerk by the council members, but not
23 in excess of the average percentage increase granted to other
24 municipal employees in the same period.

25 The municipal council of any municipality having a population
26 of more than 200,000, but less than 270,000, which, prior to
27 January 9, 1982, had adopted the form of government designated
28 as "Mayor-Council Plan C" provided for in article 5 of P.L.1960,
29 c.210 (C.40:69A-55 et seq.) may appoint not more than one aide
30 for each council member, who shall serve, and be removable at
31 the pleasure of the council member, and who shall serve in the
32 unclassified service of the civil service of the city and shall

34 salary so fixed shall not exceed ~~(\$10,000.00)~~ \$15,000.

1 **AN ACT** concerning the salaries of council aides in certain cities
2 and amending P.L.1973, c.89.

4 BE IT ENACTED *by the Senate and General Assembly of the*
5 *State of New Jersey:*

6 1. Section 1 of P.L.1973, c.89 (C.40:69A-60.5) is amended to
7 read as follows:

1. The municipal council of any municipality having a population of more than 270,000 which, prior to January 9, 1982 had adopted the form of government designated as "Mayor-Council Plan C" provided for in article 5 of P.L.1950, c.210 (C.40:69A-55 et seq.), may appoint an executive secretary and not more than four aides for each council member, who shall serve, and be removable at the pleasure of the council member, and who shall serve in the unclassified service of the civil service of the city and shall receive such salary as shall be fixed by ordinance, but said salary shall not exceed the salaries of persons holding the positions of executive secretary or aide on April 26, 1985. Persons appointed pursuant to this section may have their salaries increased on a periodic basis in accordance with the recommendation in an annual merit evaluation for each aide, to be filed with the municipal clerk by the council members, but not in excess of the average percentage increase granted to other municipal employees in the same period.

The Senate Community Affairs Committee reports favorably Assembly Bill No. 1302.

This bill would increase the allowable salary level for an aide to a council member in any municipality with a population greater than 200,000 but less than 270,000 which, prior to January 9, 1982, had adopted the "Mayor-Council Plan C" form of government provided for in article 5 of P.L.1950, c.210 (C.40:69A-55 et seq.). Under current law the annual salary limit is \$10,000. This bill would increase that salary limit to \$15,000. The only municipality currently affected by this bill is Jersey City.
