1 AN ACT providing for the issuance of certain license plates for 2 the purpose of supporting certain environmental protection 3 projects for the coastal area of this State and supplementing 4 chapter 3 of Title 39 of the Revised Statutes. 5 6 BE IT ENACTED by the Senate and General Assembly of the 7 State of New Jersey: 8 1. Application for issuance of a coastal protection license plate shall be made to the division on forms and in a manner as 37 38 may be prescribed by the director. In order to be deemed 39 complete, an application shall be accompanied by a fee of \$50, 40 which fee shall be in addition to the fee for the renewal of the registration certificate, payable to the division. 41 b. The annual fee for the registration certificate of a motor 42vehicle that has been issued a coastal protection license plate 43 pursuant to the provisions of this act shall include in each year 44

subsequent to the year of issuance a coastal protection licenseplate fee in the amount of \$10, which fee shall be in addition to

the fee for the renewal of the registration certificate, collected
 by the division and deposited into the Coastal Protection Trust
 Fund created pursuant to section 4 of this act.

4. a. There is created in the Department of the Treasury a 4 5 special non-lapsing fund to be known as the "Coastal Protection" Trust Fund." There shall be deposited in the fund the amount 6 7 collected from all license plate fees collected pursuant to section 8 3 of this act, less the amounts necessary to reimburse the division for administrative costs pursuant to section 5 of this act. Except 9 10 as otherwise provided in subsection b. of this section, monies deposited in the fund shall be dedicated to the purposes set forth 11 12 in section 6 of this act. Monies deposited in the fund shall be 13 held in interest-bearing accounts in public depositories as defined 14 pursuant to section 1 of P.L.1970, c.236 (C.17:9-41), and may be invested or reinvested in such securities as are approved by the 15 State Treasurer. (1) finance shore protection projects of an emergency nature
in the event of storm, stress of weather or similar act of God; and
(2) provide for the cleanup of discharges of pollutants or

5. a. Prior to the deposit of license plate fees collected pursuant to section 3 of this act into the fund. amounts thereof as are necessary shall be used to reimburse the division for all costs reasonably and actually incurred, as stipulated by the director, for:

(1) producing, issuing, renewing, and publicizing the
 availability of coastal protection license plates; and

(2) any initial fees, in an amount not to exceed \$150,000,

The Legislature shall annually appropriate to the 6 department from the first \$1,000,000 in license plate fees 7 8 collected pursuant to section 3 of this act and deposited in the 9 fund:

10 (1) An amount not to exceed \$600,000 for the cost of any 11 program of the department, or conducted in cooperation with the 12 Department of Corrections that utilizes prisoners to clean up or 13 maintain beaches or shores;

(2) An amount not to exceed \$200,000 for the cost of providing
aircraft overflights for monitoring, surveillance and enforcement

### STATEMENT

This bill would provide that, upon application of any person, the Director of the Division of Motor Vehicles may issue for a motor vehicle owned or leased by such person special license plates bearing, in addition to the registration number and other markings or identification otherwise prescribed by law, words or a slogan and an emblem, indicating support for, or an interest in, the protection of the New Jersey Shore.

52 The annual fee for the plates would be \$50, payable to the 53 Department of Environmental Protection (DEP), which would be 54 in addition to registration fees otherwise prescribed by law. In addition, there would be a \$10 renewal fee, also payable to the DEP. These fees would be deposited into a non-lapsing "Shore Protection Fund" established in the DEP. ### DATED: JULY 20, 1992

The Assembly Environment Committee favorably reports Assembly Bill No. 1455 with Assembly committee amendments.

Assembly Bill No. 1455, with proposed committee amendments, directs the Director of the Division of Motor Vehicles, in cooperation with the Department of Environmental Protection, to establish a special shore protection license plate program. The special plates would contain markings or identification expressing the vehicle owner's interest in shore protection. A \$50 fee shall be charged for the issuance of the special license plates, and an additional \$10 fee shall be collected for each annual renewal, which \$10 shall be in addition to the annual fee for a registration certificate renewal. Monies from such fees, referred to as "shore protection license plate fees," shall be deposited into a nonlapsing Shore Protection Fund for use for shore protection projects that are consistent with the New Jersey Shore Protection Master plan.

Applications for the special plates along with the fee therefor shall be made to the Department of Environmental Protection. Registration certificate renewals shall be made to the Division of Motor Vehicles, who shall transmit to the Department of Environmental Protection, on a monthly basis, the \$10 renewal fees collected on each set of shore protection license plates. The Division of Motor Vehicles shall be reimbursed by the Department of Environmental Protection for costs incurred by the division, as annually certified by the division, in producing, issuing, renewing, and publicizing shore protection license plates. The Department of Environmental Protection is charged with designing notices, posters and signs for use by the Division of Motor Vehicles, subject to the approval of the division. The division shall also include in all mailings of motor vehicle registration renewals a notice on the availability of shore protection license plates. The Department of Environmental Protection and the Division of Motor Vehicles shall enter into an interagency memorandum of agreement setting out the procedures for carrying out their respective responsibilities.

The proposed committee amendments:

(1) clarify that the shore protection license plate program is a mandated program;

(2) establish a special collection procedure for handling renewal fees;

(3) provide that the initial \$150,000 in fees collected from the issuance of shore protection license plates shall be allocated to the Division of Motor Vehicles to pay the cost of any computer programming changes that may be necessary to implement the shore protection license plate program established by the bill; and

(4) contain several other clarifying, technical, and nonsubstantive amendments.

# STATE OF NEW JERSEY

### DATED: MAY 6, 1993

The Senate Budget and Appropriations Committee reports favorably the Senate Committee Substitute for Assembly Bill No. 1455.

This committee substitute for Assembly Bill No. 1455 directs the Division of Motor Vehicles (DMV) to establish a special coastal protection license plate program. The special plates would contain markings or identification expressing the vehicle owner's interest in coastal protection. The Director of the Division of Motor Vehicles will select the design of the license plate, after soliciting, in conjunction with the Legislature, input from the general public and reviewing the submissions before choosing the design. A \$50 fee would be charged for the issuance of the plates, and an additional \$10 fee would be collected for each annual renewal.

The first \$1,000.000 in fees collected would be deposited into a special nonlapsing Coastal Protection Trust Fund created in the Department of the Treasury, and would be annually appropriated to the DEP for: (1) the costs incurred by DEP and the Department of Corrections in the program that utilizes prisoners to clean up or maintain beaches; (2) providing aircraft overflights for monitoring, surveillance and enforcement activities of the DEP Cooperative Coastal Monitoring Program: (3) establishing a program of grants for the construction of sewage pump-out devices for marine sanitation devices and portable toilet emptying receptacles at public or private marinas or boatyards in furtherance of the provisions of P.L.1988, c.177 (C.58:10A-57 et seq.) (commonly known as the Marine Sewage Treatment Act); and (4) implementing the "Adopt a Beach" program established pursuant to P.L.1992, c.213 (C.13:19-22 et seq.).

The bill also establishes a special emergency reserve account within the Coastal Protection Trust Fund. Fee monies collected in excess of \$1,000,000 in any given year would be deposited into the reserve account and used by DEP to finance shore protection projects of an emergent nature due to a storm, severe weather or similar act of God, and to provide for the cleanup of pollutants or contaminants discharged into ocean waters.

Costs incurred by the DMV, in producing, issuing, renewing, and publicizing shore protection license plates, as annually certified by the director, would be defrayed from fees collected. DMV is also authorized to use up to \$150.000 of the fees collected for the cost of any computer programming changes that may be necessary to implement the license plate program.

The bill directs DMV to include in all mailings of motor vehicle registration renewals a notice on the availability of shore protection license plates. The substitute requires the Joint Budget Oversight Committee to approve the Division of Motor Vehicle's annual certification of the average cost to produce, issue and renew a license plate. If the average annual cost exceed \$50 for two consecutive fiscal years, the division may discontinue the issuance of these license plates.

As reported by the committee, this committee substitute is identical to the Senate Committee Substitute for Senate Bill 988 of 1992 as amended and reported by this committee on March 6, 1993.

#### FISCAL IMPACT

The Office of Legislative Services estimates that this bill would generate revenues of \$2,250.000 in the first year, \$2,700,000 in the second year and \$3,150,000 in the third year following the bill's enactment. These revenues would offset the costs incurred by DMV and produce net surpluses of \$1,729,845 for the first year, \$2,322,068 for the second year and \$2,768,021 for the third year for deposit into the "Coastal Protection Trust Fund" created by the bill.

This estimate is based on information provided by DMV that 45,000 motorists would apply for the plates annually and that all plate holders would renew their plates. DMV estimates that it would incur costs of \$520,155 for the first year, \$377,932 for the second year, and \$381,979 for the third year as a result of implementing this bill.

In addition, the bill specifies the amounts to be appropriated to DEP annually from the "Coastal Protection Trust Fund." To be appropriated is an amount not to exceed (1) \$600,000 for the costs incurred by DEP and the Department of Corrections in the "Operation Clean Shores" program that utilizes prisoners to clean up or maintain beaches; (2) \$200,000 for aircraft overflights for monitoring, surveillance and enforcement activities of the DEP Cooperative Coastal Monitoring Program; (3) \$150,000 to establish a program of grants for the construction of sewage pump-out devices for marine sanitation devices and portable toilet emptying receptacles at public or private marinas or boatyards in furtherance of the provisions of P.L.1988, c.177 (C.58:10A-57 et seq.) (commonly known as the Marine Sewage Treatment Act); and (4) \$50.000 to implement the "Adopt a Beach" program established pursuant to P.L.1992, c.213 (C.13:19-22 et seq.).

Monies collected in excess of \$1,000,000 are to be used by DEP to finance shore protection projects of an emergent nature and to provide for the cleanup of pollutants or contaminants discharged into ocean waters.

# STATE OF NEW JERSEY

### DATED: December 3, 1992

Assembly Bill No. 1455 (2R) of 1992 permits the Director of the Division of Motor Vehicles (DMV) in the Department of Law and Public Safety to issue for a motor vehicle owned or leased by the applicant special license plates indicating support for, or an interest in, the protection of the New Jersey Shore.

Application for the plates would be made to DMV, accompanied by a fee of \$50. The annual renewal fee for the plates would be \$10. These fees would be in addition to the motor vehicle registration fees otherwise prescribed by law and would be deposited into a non-lapsing "Shore Protection Fund" established in DEPE. Interest or other income earned on monies deposited into the Shore Protection Fund would be credited to the fund. Monies in the fund could be used by the Department of Environmental Protection and Energy (DEPE) to reimburse DMV for all costs incurred, as stipulated by the director, in producing, issuing and publicizing the availability of shore protection license plates and to finance the cost of shore protection projects developed by DEPE consistent with the New Jersey Shore Protection Master Plan.

The Director of the DMV would be required to publicize the shore protection license plates by including a notice with all motor vehicle registration renewals and by posting appropriate posters or signs, as may be provided by DEPE, in DMV facilities.

The bill also dedicates the initial \$150,000 in fees collected from the issuance of shore protection license plates for DMV computer programming costs associated with the bill's implementation.

DMV estimates the cost of implementing this bill at \$520,155 in the first year after enactment. Of this amount, \$146,077 would be for one-time computer programming and die costs. According to DMV. the remaining \$374.078 represents funding for the following operational costs: \$59,913 for salaries for three personnel, \$17,165 for fringe benefits, and \$297,000 for materials and supplies. Assuming a 5 percent annual increase for salaries and fringe benefits, DMV estimates second and third year costs at \$377,932 and \$381,979, respectively.

DMV estimates revenues from licensing fees at \$2,250,000, \$2,700,000 and \$3,150,000 in the first three years following the bill's enactment, respectively. These revenues would offset DMV's costs and produce net surpluses of \$1.729.845, \$2,322,068 and \$2,768,021, respectively. In its cost and revenue estimates, DMV assumes that 45,000 motorists would apply for the plates annually and that all plate holders would renew their plates.

The Office of Legislative Services (OLS) concurs.

### SHORE PROTECTION TO BENEFIT FROM DISASTER RELIEF AND NEW LICENSE PLATES

JERSEY SHORE - Praising the hard work of those who have made the Jersey Shore open and ready for business, Governor Jim Florio, on a tour of the shore, today delivered checks totalling more than \$5.4 million to 183 communities and state, local and county government agencies in the latest round of federal disaster assistance following last December's devastating Nor'Easter. Later today, in Atlantic City, he was to sign a bill creating a special shore license plate which will provide an important new source of funds for shore protection.

"This year is special. We were here during the devastating winter storms. Now, we're going to enjoy the rebirth of the Jersey Shore with thousands of happy visitors," said Governor Florio, who announced the latest round of checks during a Shore Tour Kick-Off Breakfast of shore community mayors and tourism officials. Following the breakfast, the Jersey Shore Tour was to travel by train from Long Branch to Belmar, where the Governor was to visit the boardwalk and view lifeguard drills.

"It's quite a testament to the spirit and resilience of our people. We all worked together in a race against the clock to get ready for summer. And we're going to keep working together until the job is done," he said.

Today's funding round -- \$5,433,420 -- covers emergency response costs, debris removal and repairs to public facilities, including beach restoration. The Federal Emergency Management Agency (FEMA) provides at a minimum, 75 percent of the eligible assistance costs. States and municipalities traditionally each provide 12.5 percent. In February, the Governor announced that the state would pick up the full 25 percent matching tab usually split between the state and local communities in an effort to further aid hard-hit communities.

"Certainly the cooperation between FEMA and the state has been outstanding. That kind of cooperation has enabled us to disperse checks in a timely fashion. FEMA looks forward to continuing to work with the state in bringing this disaster operation to a successful close, and in the future, implement hazard mitigation projects that will minimize future damages," said Stephen Kempf, FEMA Federal Coordinating Officer. With today's announcement, the City of Long Branch will receive an additional \$25,150 and Belmar received \$219,750. To date, nearly \$40 million has been approved for local communities in federal and state disaster aid. A complete list of recipients receiving federal assistance today is attached (some received more than one check).

"Fourth of July is the great American Summer Holiday and there's no better place to celebrate than our magnificent Jersey Shore," said Governor Florio. "We're open and ready for business. The water's sparkling clean and so are our beaches. We've rebuilt our boardwalks. We're reclaiming the sand and re-establishing our sand dunes and seawall."

"All the indicators tell us that the tourists are coming and coming and coming. This year promises to be one of the best ever for business and jobs at the Jersey Shore," he said. Tourism is the state's second largest industry, generating \$18 billion and creating thousands of jobs.

### License Plate Bill Signing

Later today, Governor Florio was to visit the boardwalk in Atlantic City. Shore lovers cannot only wear their heart on their sleeve, but on the bumper of their car under legislation to create a special coastal license plate with proceeds dedicated to shore protection projects.

"This is a great way for New Jerseyans to show how much we appreciate the Jersey Shore, and it will provide an important new source of funds for shore protection," said Governor Florio. "It will give New Jerseyans a chance to contribute directly to shore protection and it guarantees that the funds we raise are dedicated directly to the Jersey Shore."

Under the new law, the state Division of Motor Vehicles will issue a special coastal protection license plate. The plate will be available for \$50, with an additional \$10 fee collected annually with registration renewals. Proceeds would go for shore protection projects and to offset the costs of the license plate. A contest will be held to determine the design of the plate.

The first \$1 million raised each year -- which would be reached with the purchase of 20,000 plates -- will go to four programs that are national models for clean water and clean beaches:

- up to \$600,000 for the Operation Clean Shores program which uses minimum security prison inmates to clean-up the state's 127 miles of coastline.
- up to \$200,000 to provide aircraft flights to maintain the Cooperative Coastal Monitoring Program
- up to \$150,000 for grants to construct sewage pumps and devices
- for marine sanitation at public or private marinas or boatyards. Up to \$50,000 to implement the "Adopt-a-Beach Program".

Funds exceeding \$1 million would be deposited in a "Coastal Protection Trust Fund", a special reserve account for ocean pollution emergencies and shore protection projects after storms.

Designs will be accepted through July 31 for the license plate which is expected to be available by year end. So far, designs have been submitted by the Silver Bay Elementary School third grade class in Toms River.

The license plate legislation, A 1455, was sponsored by Assemblypersons Virginia Haines and David Wolfe.

"Our new shore protection plates are a good way to involve more New Jerseyans in shore protection," said Governor Florio. "They are a great reminder to everyone on the road that you *can* make a difference. Each time a new plate is sold or your license is renewed, the shore will benefit and so will all the people of New Jersey."
