INTRODUCED MARCH 16, 1992

By Senator CORMAN

1 AN ACT concerning food establishments and supplementing
2 P.L.1968, c.105 (C.24:16B-1 et seq.).

3

4 BE IT ENACTED *by the Senate and General Assembly of the*
5 *State of New Jersey:*

6 1. A food bank, as defined in section 2 of P.L.1982, c.178
7 (C.24:4A-2), or a nonprofit organization that provides food to the
8 needy, may accept the donation of and serve the meat of wild
9 game animals, killed during the hunting season, if the following
10 requirements are met:

11 a. The meat is prepared and packaged ¹[by a person licensed
12 pursuant to P.L.1968, c.105 (C.24:16B-1 et seq.)] pursuant to the
13 "Wholesome Meat Act," Pub. L. 90-201 (21 U.S.C. §601 et seq)¹;
14 and

15 b. The package or container in which the meat is transported
16 is labeled as "not for sale."

17 2. This act shall take effect immediately.

The Assembly Senior Citizens and Social Services Committee favorably reports Senate Bill No. 598.

This bill allows hunters to donate the meat of wild game animals to food banks or organizations that provide food to indigents. In order for the food bank or organization to accept the donation, the meat must be prepared and packaged by a person licensed pursuant to P.L.1968, c.105 (C.24:16B-1 et seq.) and it must be labeled "not for sale."

This bill is identical to Assembly Bill No. 1938 (Kronick/Roma) which was released from this committee on this date.

The Senate Health and Human Services Committee favorably reports Senate Bill No. 598.

This bill allows hunters to donate the meat of wild game animals to food banks or organizations that provide food to indigents. In order for the food bank or organization to accept the donation, the meat must be prepared and packaged by a person licensed pursuant to P.L.1968, c.105 (C.24:16B-1 et seq.), the New Jersey Meat and Poultry Inspection Act, and it must be labeled "not for sale."
