1 AN ACT concerning leave of absence to attend State or national
2 conventions and amending R.S.38:23-2.

4 BE IT ENACTED by the Senate and General Assembly of the
5 State of New Jersey:

6 1. R.S.38:23-2 is amended to read as follows:

7 38:2-2. The head of every public department and of every
8 court of this State, every superintendent or foreman on the public
9 works of this State, the heads of the county offices of the several
10 counties and the head of every department, bureau and office in
11 the government of the various municipalities, shall give a leave
12 of absence with pay to every person in the service of the State,
13 county or municipality who is a duly authorized representative of
14 the Grand Army of the Republic, United Spanish-American War
15 Veterans, Disabled American Veterans, Disabled American
16 Veterans' Auxiliary, Veterans of Foreign Wars, Ladies
17 Auxiliaries of Veterans of Foreign Wars, Ladies Auxiliary,
18 Veterans of World War I of the U.S.A., American Gold Star
19 Mothers, Indian War Veterans, American Legion, American
20 Legion Auxiliary, Jewish War Veterans of the United States,
21 Ladies Auxiliary, Department of New Jersey, Jewish War
22 Veterans of the U.S.A., Catholic War Veterans of the United
23 States, Ladies Auxiliary of New Jersey State Department,
24 Catholic War Veterans, The 389th Veterans Association,
25 incorporated, Women's Overseas Service League, American
26 Veterans of World War Two, Korea and Vietnam, and AMVETS
27 Ladies Auxiliary, Reserve Officers Association of the United
28 States, Marine Corps League of the United States, Army and
29 Navy Legion of Valor, the Twenty-ninth Division Association,
30 Council of State Employees, War Veteran Public Employees
31 Association, New Jersey Civil Service Association, Blind
32 Veterans Association of New Jersey, Army and Air National
33 Guard Association of New Jersey, The National Guard
34 Association of the United States, The United States Coast Guard
35 Auxiliary, Navy League, Veterans of World War I of the United
36 States of America, Polish Legion of American Veterans, Polish
