## STATE OF NEW JERSEY

#### INTRODUCED DECEMBER 3, 1990

By Assemblywoman FORD, Assemblymen DOYLE, Cimino and Baer

AN ACT establishing the "Governor's Lyme Disease Advisory Council."

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

- 1. The Legislature finds and declares that:
- a. Lyme disease is a bacterial infection which is spread by <sup>2</sup>[deer ticks] <u>certain arthropods</u><sup>2</sup> and is one of the fastest growing public health problems in New Jersey;
- b. There is evidence that the disease may be transmitted through blood products, shared needles, raw milk and blood-sucking insects;
- c. Lyme disease, which is the most common tick-borne disease in this country, is present <sup>2</sup>[at all times in 23] in 48<sup>2</sup> states and <sup>2</sup>[appears to be] five continents and is<sup>2</sup> spreading, <sup>2</sup>[and New Jersey is] with New Jersey being<sup>2</sup> one of the states in which the disease is most prevalent;
- d. Lyme disease was not widely recognized in the United States until 1975 and was first identified in New Jersey in Monmouth county in 1978;
- e. Because Lyme disease is still relatively unknown among both the medical community and the general public, it is often misdiagnosed or not diagnosed, which results in more serious health problems for the affected person; and
- f. If untreated, Lyme disease, in its later stages, can result in neurological disorders, including<sup>2</sup>, but not limited to,<sup>2</sup> chronic and severe fatigue, encephalitis, meningitis, memory loss, dementia and seizures; severe arthritis; cardiac <sup>2</sup>[complications] dysfunction<sup>2</sup>; vision <sup>2</sup>[difficulties and stomach disorders] loss, gastrointestinal disorders, paralysis, strokes and death<sup>2</sup>.
- 2. There is created a  $^2$ [nine-member]  $^{13-\text{member}^2}$  "Governor's Lyme Disease Advisory Council." The council shall consist of: the Commissioners of the Departments of Environmental Protection, Health and Education, or their designees, who shall serve ex officio; and  $^2$ [six]  $^{10}$  public members who by virtue of education or experience are knowledgeable about the problems of Lyme disease,  $^2$ [two of whom are]  $^2$  appointed by the Governor,  $^2$  at least  $^2$  one of

whom shall be a physician  $\frac{1}{2}$  and  $\frac{2}{2}$  [the other] at least one of whom shall be  $^2$  a veterinarian  $^1$ , two  $^2$ [of whom are] to be  $^2$  appointed by the President of the Senate and two <sup>2</sup>[of whom are] to be<sup>2</sup> appointed by the Speaker of the General Assembly.

The public members shall serve for three year terms or until a successor is appointed; but of the members initially appointed,  $^{2}$ [three]  $^{1}$  shall serve for a term of three years and  $^{2}$ [three] five<sup>2</sup> shall serve for a term of two years.

Vacancies in the membership of the council shall be filled in the same manner as the original appointments are made and a member may be eligible for reappointment. Vacancies occurring other than by expiration of a term shall be filled for the unexpired term.

The members of the council shall serve without compensation but shall be reimbursed for traveling and other miscellaneous expenses necessary to perform their duties, within the limits of funds appropriated or otherwise made available to the council for its purposes.

- 3. The council shall advise the Governor regarding the prevention, detection, occurrence, <sup>2</sup>diagnosis, <sup>2</sup> treatment and cure of Lyme disease, and shall establish a mechanism through which physicians and communities throughout the State can share information on the disease.
- 4. The council shall organize as soon after the appointment of its members as is practicable. A majority of the council members shall elect a chairperson and a secretary who need not be a member of the council. The council shall meet at regular intervals but at least on a monthly basis.
- 5. The council is entitled to call to its assistance and avail itself of the services of any State, county or municipal department, board, bureau, commission or agency as it may require and as may be available to it for its purposes. #### **STATEMENT**

This bill establishes a nine-member "Governor's Lyme Disease Advisory Council. The purpose of the council is to advise the Governor regarding the prevention, detection, occurrence, treatment and cure of Lyme disease and to establish a mechanism through which physicians and communities throughout the State can share information on the disease. The council shall report to the Governor and the Legislature on its progress on an annual basis.

The membership of the council consists of the Commissioners of the Departments of Environmental Protection, Health and

### STATE OF NEW JERSEY

The Assembly Health and Human Services Committee favorably reports Assembly Bill No. 4223 with committee amendments.

As amended by the committee, this bill establishes a nine-member "Governor's Lyme Disease Advisory Council." The purpose of the council is to advise the Governor regarding the prevention, detection, occurrence, treatment and cure of Lyme disease and to establish a mechanism through which physicians and communities throughout the State can share information on the disease. The council is to submit an annual report to the Governor and the Legislature by March 1 of each year.

The amended bill provides that the council membership will include: the Commissioners of Environmental Protection, Health and Education, or their designees, and six public members who through education or experience are knowledgeable about Lyme disease, two to be appointed by the Governor, one of whom shall be a physician and the other a veterinarian, and two each to be appointed by the President of the Senate and the Speaker of the General Assembly.

The Department of the Treasury is to provide such professional, stenographic and clerical assistance as the council requires to perform its duties.

The committee amended the bill at the sponsor's request to designate that one of the gubernatorial appointments to the council shall be a veterinarian. The amendment reflects the fact that veterinarians repeatedly are in contact with animals which may be carriers of the deer tick that causes Lyme disease, and have been involved with the development of preventive measures and possible treatments for the disease.

#### STATE OF NEW JERSEY

The Senate Institutions, Health and Welfare Committee favorably reports Assembly Bill No. 4223 [1R] with committee amendments.

As amended by committee, this bill establishes a 13-member "Governor's Lyme Disease Advisory Council." The purpose of the council is to advise the Governor regarding the prevention, detection, occurrence, diagnosis, treatment and cure of Lyme disease and to establish a mechanism through which physicians and communities throughout the State can share information on the disease. The council is to submit an annual report to the Governor and the Legislature by March 1 of each year.

The bill provides that the council membership will include: the Commissioners of Environmental Protection, Health and Education, or their designees, and 10 public members who through education or experience are knowledgeable about Lyme disease, six to be appointed by the Governor, at least one of whom shall be a physician and at least one of whom shall be a veterinarian, and two each to be appointed by the President of the Senate and the Speaker of the General Assembly.

The Department of the Treasury is to provide such professional, stenographic and clerical assistance as the council requires to perform its duties.

The committee amended the bill to increase the size of the council from nine to 13 members by adding four public members who will be appointed by the Governor. The amendments also provide that the council shall advise the Governor regarding the diagnosis of Lyme disease, as well as its prevention, detection, occurrence, treatment and cure. Finally, the amendments incorporate additional informational language in the legislative findings and declaration section of the bill in order to clarify the nature and dimensions of the Lyme disease problem.

Governor Jim Florio today signed a bill creating the Governor's Lyme Disease Advisory Council, which will assist New Jersey in the fight to eradicate Lyme Disease.

"Through this council, we can establish better communication about this tragic disease," Governor Florio said. "We can establish a partnership with the medical community and all communities in the state to explore new ways to share information, educate others and fight this disease."

The new law establishes a 13-member council to advise the Governor regarding Lyme Disease and to establish a system through which communities and physicians can share information on the disease.

The new law follows the creation last year of a Lyme Disease hotline to serve as a clearinghouse of information for people throughout the state.

The bill signing was attended by Mary Schmidt, of Sayreville, whose daughter, Mandy Lynn, was the first recorded death in New Jersey from Lyme Disease.

"The efforts of people like Mary Schmidt have made an important difference. She has helped others live with Lyme Disease and has helped raise awareness about the disease and educate others," Governor Florio said.
