AN ACT to amend "An act concerning the annual salaries of the justices and judges of State and county courts and the establishment of salary ranges for certain offices and positions in the judicial branch of the State Government, and repealing P. L. 1970, c. 105," approved June 28, 1974 (P. L. 1974, c. 57) and making an appropriation.

1 BE IT ENACTED by the Senate and General Assembly of the State
2 of New Jersey:

1 1. Section 1 of P. L. 1974, c. 57 (C. 2A:1A-6) is amended to read
