The Senate Committee on Children's Services favorably reports Senate Bill No. 854.

This bill abolishes the New Jersey State Youth Commission and the Advisory Council on the Chronic Sick. The Advisory Council on the Chronic Sick has been inactive for over 10 years. The duties and responsibilities of the State Youth Commission, which has also been inactive, have been assumed by the Governor's Committee on Children's Services Planning.

The bill repeals P. L. 1961, c. 140 (C. 9:23A-1 et seq.) and sections 7 through 10, inclusive, of P. L. 1952, c. 102 (C. 26:1A-98 through 101).

This bill was pre-filed for introduction in the 1986 session pending technical review. As reported, the bill includes the changes required by technical review which has been performed.
