AN ACT concerning education and amending sections 18A:10-3 and  
18A:12-17 of the New Jersey Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*  
2 *of New Jersey:*

1 1. Section 18A:10-3 of the New Jersey Statutes is amended to  
2 read as follows:

3 18A:10-3. Each board of education shall organize annually at  
4 a regular meeting held not later than at 8 p.m.

5 a. In Type I district on **February** *July 1*, **except that in cities**  
6 **of the first class it shall be held on July 1,** or on the following  
7 day, if that day be Sunday;

8 b. In Type II districts on the first Monday following the annual  
9 school election**[,]**, *except that in districts having an appointed*  
10 *board of education the meeting shall be held on July 1 or on the*  
11 *following day, if July 1 be Sunday.*

12 If the organization meeting cannot take place on that day by  
13 reason of lack of a quorum or for any other reason, said meeting  
14 shall be held within 3 days thereafter.

1 2. Section 18A:12-17 of the New Jersey Statutes is amended to  
2 read as follows:

3 18A:12-17. The mayor or other chief executive officer of the  
4 municipality shall, between January 2 and January 15 in each year,  
5 appoint one member of the board to serve for a term of 5 years  
6 beginning on **February** *July 1* next succeeding his appointment,  
7 to take the place of the member whose term shall expire in that  
8 year, and any vacancy occurring in the membership of the board  
9 shall be reported forthwith by the secretary of the board to the  
10 mayor or other chief executive officer of the municipality, who

11 shall within 30 days thereafter appoint a qualified person to fill  
12 the vacancy for the unexpired term.

1 3. This act shall take effect immediately.

#### STATEMENT

This is a companion bill to Senate Bill No. 355, which would change the effective date of appointment of school board members in Type I districts (other than in cities of the first class) from February 1 to July 1. The purpose of this bill is to make the corresponding change in 18A:10-3 with respect to the organization meeting of the new board of education, and in section 18A:12-17, which provides for the special case of appointed board of education in Type II districts.
