AN ACT to supplement "An act concerning medical service corporations and regulating the establishment, maintenance and operation of medical service corporations, and supplementing Title 17 of the Revised Statutes by adding thereto a new chapter entitled 'Medical Service Corporations,' " approved May 29, 1940 (P. L. 1940, c. 74; C. 17:48A-1 et seq.), as said title was amended by P. L. 1977, c. 95.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Notwithstanding any other provision of P. L. 1940, c. 74
2 (C. 17:48A-1 et seq.), benefits shall not be denied to any eligible
3 individual for eligible services when such services are performed
4 or rendered such persons by a licensed chiropractor within the
5 scope of his practice. The practice of chiropractic shall be deemed
6 to be within the provisions of P. L. 1940, c. 74 and duly licensed
7 chiropractors shall have the privileges and benefits in the scope
8 of their practice under the act as are afforded to licensed physicians
9 and surgeons in the scope of their practice.

1 2. This act shall take effect immediately.

Governor Brendan Byrne has signed the following bills.

S-1321, sponsored by Senator William V. Musto (D-Hudson) which supplements the Medical Service Corporation Act to provide that Blue Cross and Blue Shield and other non-commercial carriers cannot deny benefits to an eligible individual for eligible services because those services are provided by a chiropractor.

S-1370, sponsored by Senator Joseph P. Merlino (D-Mercer), which amends the section of the Casino Reform Package prohibiting any person licensed by or registered with the Casino Control Commission from offering or providing employment to those public officials prohibited from accepting same by the casino ethics law.

The bill changes the offense of offering employment from a civil offense with a penalty of \$5,000 to \$10,000 to a crime of the fourth degree which has a maximum penalty of \$7,500 and 18 months incarceration.

It also amends the definition of "person" to correspond with the definition under S-1369, with the Governor's recommendations.
